Ask Ann, City of Ann Arbor's Virtual Assistant, is Now Live. The City of Ann Arbor is launching Ask Ann, a fully integrated and automated web chat assistant to help people find information available from the city's website, www.a2gov.org, 24/7.

Ask Ann is built into the city website, using the technology behind large language models, or conversational artificial intelligence (AI), which makes it easier for anyone to get quick answers to questions, find detailed information on city services and projects, submit service requests, and contact staff. Leveraging the latest technology and machine learning, Ask Ann understands and communicates proficiently in 71 different languages, showcasing the advancements in conversational AI for a more seamless and inclusive customer experience.

To chat with Ask Ann, people only have to visit the city website, www.a2gov.org, where both desktop and mobile users will notice the feature on the bottom right section of their browser window. Clicking on the Ask Ann icon launches the chat window, greeting visitors and prompting them to enter their question.

If at any time during the chat a person needs further assistance, they can send in a message with Ask Ann and a member of city staff will follow up during business hours.

To bring this new tool to life, the City of Ann Arbor partnered with Citibot, based in Charleston, South Carolina. The City of Ann Arbor is among the first municipalities in Michigan to implement the Citibot customer service solution.

Prepare for Nov. 5 General Election. If you still need to register to vote, and if you still need to register to vote in Ann Arbor (residents who've recently moved to the city, students, recently eligible voters, for example), you may do so now, in two different ways:

In person at the Ann Arbor City Clerk's Office, second floor of Larcom City Hall, 301 E. Huron St. The city clerk's office is open 8 a.m.–5 p.m. daily.

Online at the Michigan Voter Information Center.

Registered voters still needing to apply for an absentee ballot can request an absentee ballot online at the <u>Michigan Voter Information Center</u>; by printing out and submitting an application; or in person at the Ann Arbor City Clerk's office. Visit <u>a2gov.org/elections</u> for details.

<u>Early voting</u> in the General Election will begin nine days before Election Day (on Saturday, Oct. 26) and will continue through Sunday, Nov. 3.

Ann Arbor Parks & Recreation Millage to Appear on Nov. 5 General Election Ballot. The 2025–2044 Park Maintenance and Capital Improvements Millage renewal proposal is set to appear on the Nov. 5 General Election ballot, asking Ann Arbor voters to decide whether to continue supporting the Ann Arbor park system. If passed, the renewed millage would continue funding park system enhancements, repairs and restoration for the next 20 years. The millage renewal proposal remains for 1.10 mills and does not pose an increase; the rate would remain the same as the millage that is expiring this year. LAND ACKNOWLEDGEMENT

Equity and justice are at the center of A²ZERO and staff in OSI are continuing to ground our work in these critical principles. In that light, we'd like to take a moment to honor the geographic and historic space we share. We acknowledge that the land the City of Ann Arbor occupies is the ancestral, traditional, and contemporary lands of the Anishinaabe and Wyandot peoples. We further acknowledge that our city stands, like almost all property in the United States, on lands obtained, generally in unconscionable ways, from indigenous peoples. The taking of this land was formalized by the Treaty of Detroit in 1807. Knowing where we live, work, study, and recreate does not change the past, but a thorough understanding of the ongoing consequences of this past can empower us in our work to create a future that supports human flourishing and justice for all individuals.

DEEPLY ROOTED IN LOCAL FOOD

A LOCAL FOOD SYSTEM WORTH CELEBRATING

Ann Arbor is a community rich in local food. Thriving agricultural and culinary communities make the city a hub for food-lovers and farm-to-table connoisseurs. While for some, local food may be an exciting dining experience, our local food system offers benefits that extend well beyond the dinner table. As our community grapples with the impacts of climate change, alongside other social and economic pressures, local food systems can foster community resilience, bolster economic vitality, and help promote a culture of sustainability.

As we look forward to the 3rd annual Ann Arbor Local Food Festival, let's explore the benefits of investing in a strong local food system here in Ann Arbor.

The Global Food System Today

The journey of food from farm to plate is often complex and largely unseen. This journey begins with soil, sunlight, and water on a farm, and progresses through a complex network of producers, processors, transporters, distributors, and retailers. This network, known as the <u>food system</u>, is shaped by various stakeholders including businesses, scientists, policy makers, and consumers.

Today's food system often relies on global supply chains, with food traveling an average of 1,500 miles before reaching our tables. This globalization of our food system is what enables us to enjoy diverse foods year-round, from avocados from Mexico to grapes from Chile and coffee from Kenya. However, reliance on global chains also makes communities vulnerable to disruptions caused by social, environmental, and political factors. Such disruptions can lead to food shortages and exacerbate food insecurity experienced throughout a community, as evidenced during the COVID-19 pandemic, which exposed weaknesses in global supply chains and highlighted disparities in food access, particularly among already marginalized communities.

Understanding the Role of Local Food

Local food systems can address these vulnerabilities in several ways, including increased economic prosperity, food security, environmental sustainability, and strengthened community bonds. By reducing reliance on lengthy supply chains, local food systems can better withstand disruptions caused by natural disasters, economic downturns, or global crises. Many local farms also promote ecological resilience by using organic or regenerative agricultural practices that protect soil health, water resources, and minimize chemical impacts.

In addition to these benefits, local food systems also contribute to overall community and economic prosperity. By shopping locally, consumers can directly support farmers and producers, ensuring they receive a fairer share of the consumer dollar. This fosters local entrepreneurship and job creation and strengthens the community's economy. Furthermore, local food systems can preserve cultural heritage by maintaining traditional crops and agricultural or culinary knowledge. Most importantly, they build community resilience by fostering social connectivity, enabling communities to adapt, collaborate, and thrive through shared commitment and mutual support.

DEEPLY ROOTED IN LOCAL FOOD

A LOCAL FOOD SYSTEM WORTH CELEBRATING

Local Food in Ann Arbor & Washtenaw County

Ann Arbor boasts a vibrant local food community, spearheaded by a diverse group of local leaders and advocates – from farmers and chefs to engaged community members. This dynamic food scene is a key part of the city's unique character and community pride. Michigan, the second most agriculturally diverse state in the U.S., benefits from the "lake effect" and fertile soils, making it a leader in growing a wide range of crops, including asparagus, dry beans, squash, blueberries, and tart cherries!

In Washtenaw County, a rich history of local food production and support has led to the growth of a burgeoning local food movement. With over 1,250 farms, many small-scale and family-run, the area stands out for its concentration of small, sustainable farms amidst a global trend towards industrial agriculture. This success can be attributed to community support for local, organic, and sustainable foods, and supportive policies from local governments, according to an article from Second Wave Media.

Check out the article on **page 4** for a feature on how Ann Arbor's Greenbelt program is revolutionizing agricultural land preservation and helping new farmers enter the scene.

Here in Ann Arbor, the 105-year-old <u>Ann Arbor Farmers Market</u> plays a crucial role, providing a venue for the sale of local agricultural products and fostering community connections. The market is one of the oldest in the country, and provides a lively space for neighbors to gather, share ideas and knowledge, and build relationships. It also addresses food insecurity through programs like <u>Double Up Food Bucks</u>, which offers a dollar-for-dollar match on fruits and vegetables for those using a Michigan Bridge card, up to \$15 per day.

Additionally, <u>Argus Farm Stop</u>, which this year celebrates its 10-year anniversary, has become a pillar of the Ann Arbor community. Argus is among the first of an up-and-coming local food retail model, <u>the farm stop</u>. In this model, the store sells food on consignment from nearby farms. The farmers set their own prices and keep 70% of the revenue, compared to <u>the national average of 15%</u> going to growers who

sell to supermarkets. The farm stop model provides the daily convenience of the year-round grocery store, while bolstering local food and farm viability. To read more about the impacts of farm stops, check out this article.

Alongside the rich local food retail offerings, the area is also home to several nonprofit organizations providing leadership in local and regional food system development, including Food Gatherers, Project Grow, Growing Hope, The Farm at Trinity Health, Willow Run Acres, We the People Opportunity Farm, and Fair Food Network, among others. These organizations are working to transform our local food system by eliminating hunger, promoting justice and equity in the food system, encouraging food entrepreneurship, eliminating food waste, training new gardeners and farmers, and more.

Supporting local food systems is not just about how we eat – its about how we live and thrive together. It's about recognizing the value of community-based agriculture, honoring the work of local farmers, and investing in a future where resilience, sustainability, and prosperity go hand in hand. Ann Arbor already has many of the ingredients that make a strong local food system. As we confront the interconnected challenges of climate change and social justice, it's important for our community to continue investing in and supporting the local food system to ensure a resilient, inclusive, and sustainable food system for generations to come.

PROTECTING FARMLAND, SUPPORTING NEW FARMERS

THE ANN ARBOR GREENBELT PROGRAM'S INNOVATIVE APPROACH TO FARMLAND PRESERVATION

New and beginning farmers across the country face significant challenges in accessing affordable land. With farmland prices reaching record highs, many emerging farmers struggle to acquire land. According to a 2022 survey by the National Young Farmers Coalition, the lack of affordable farmland is the most pressing issue for new farmers, with the challenge being even more severe for farmers of color who face additional systemic barriers.

Preserving agricultural land and increasing its affordability for new farmers is paramount for maintaining food security and supporting environmental health. Farmland plays <u>a vital role</u> in sequestering carbon, protecting water quality, providing habitat for wildlife, and sustaining ecosystems. <u>The American Farmland Trust</u> projects that nearly 300 million acres of U.S. agricultural land will change hands by 2040 as aging farmers retire. Without proactive measures, much of this land could be lost to development, which could threaten both our food supply and the health of local ecosystems.

The City of Ann Arbor Greenbelt Program's Buy-Protect-Sell Initiative

To address and tackle land access challenges within Washtenaw County, the City of Ann Arbor Greenbelt Program has introduced the Buy-Protect-Sell initiative (BPS). This program aims to connect land-insecure farmers to affordable farmland buying opportunities by offering conserved land at reduced prices.

This year, the Greenbelt completed its first parcel sale under the BPS initiative. Kristen Muehlhauser of Raindance Organic Farm was selected as the buyer of the south side of the farm, while Matt Demmon of Feral Flora, as the buyer of the north side. Muehlhauser, who has managed her farm on leased land since 2018, will transition her operations to this new property over the next year. She expressed her gratitude, saying, "I am incredibly grateful for this opportunity to steward this land for a lifetime... Now we have a farm to call home. That long-term commitment means we are able to invest our time, labor and funds in building healthy soil, in water lines, in pollinator plantings, in fruiting trees and perennial shrubs."

Demmon, who has operated Feral Flora on leased land since 2018, will use the north parcel to grow native perennials and prairie species for seed production. He aims to produce 500 pounds of native seeds annually, enough for 50 acres of prairie plantings each year. He stated, "I intend to put these practices to work on the Nollar Road property... I care deeply about the health of the land and all life that might utilize it, far into the future."

Since its inception in 2003, the Greenbelt Program has preserved over 7,600 acres of land. Most of this has been achieved through conservation easements on private properties, which restrict land use to agricultural, recreational, or conservation purposes.

The introduction of the Buy-Protect-Sell initiative marks a significant step in addressing the critical challenge of land access faced by new and beginning farmers. As the landscape of American agriculture shifts and pressures on new farmers intensify, initiatives like BPS are essential for ensuring that emerging farmers can secure the land they need to thrive.



The Home Energy Rating Disclosure (HERD) Ordinance provides consumer protections by requiring that a Home Energy Score (HES) assessment be conducted before a home lists for sale. The HERD Ordinance also requires that the Home Energy Score and Report be included in a real estate listing and made available to all potential buyers. The Office of Sustainability and Innovations wants to recognize the listing agents in Ann Arbor who have been early allies in the successful roll-out of the HERD Ordinance by using best practices that provide visibility and ease of access to information when including the Home Energy Score and Report in their listings.
