My name is Julie Lin, I am one of the home owners whose properties are affected by the Nixon/Traver Sidewalk project. Just like many other property owners, I object to use the special assessments to force the property owners on Jackson Road, Nixon/Traver and Barton Drive to pay for the sidewalk project intended for the public benefit, not for the property owner's benefit.

I talked to many of my friends and relatives who live in different cities in the America, They all agree that there are Ordinance similar to Ann Arbor City's Special Assessment, in their cities, but most of their City councils are reluctant to pass this kind of inequitable resolution to force the property owners to pay for building a public sidewalk for fear of the back fire from their constituents.

A project characterized by imposing extremely inequitable financial burden to a small group of targeted citizens will be like the Knees of the city councils kneeling into the targeted property owners' necks which is very cruel and will definitely result in the resentment and resistance from the affected property owners and also exacerbate the constituents' distrust to the council members who was voted by them to represent their interest.

We have already pulled the contract from the 6/15 meeting, postponing it until ICPOC has a chance to weigh in. This was 100% the right decision.

I have engaged in conversations regarding the one-year contract with city staff. If the police officers do not consent to these changes, we do run the risk of being forced into binding arbitration (an unfortunate state law). This would be catastrophic in terms of achieving our goals of rethinking public safety. Therefore, while it is certainly my hope that a one-year compromise can be achieved, I do not want to make promises that are somewhat beyond my control.

Tonight was the first city council meeting that I have joined, but I did not meet the 4:00pm comment cut off so I was hoping I could send my comments to you. Upon reviewing the budget for FY2020, it really stood out to me that the police budget is \$30M. I agree with what a commenter said tonight and we need to work to decrease the budget over time. Currently, there are over 120 police officers in Ann Arbor and on average only 30 crimes per month. What are they all doing? We need to be looking at optimization of staffing and this seems like a gross overestimation of need. Also, I noticed that there were line items for new tasers and bullet proof vests. In a city with so low crime, I have to wonder, what are those needed for? When was the last time they bought these items? Are they old? There needs to be more scrutiny of these requests. Also, where is the line item for training? Is there a sexual assault advocacy group?

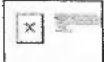

I understand the intent behind the resolution and appreciate your attention to police reform, but I am worried like others that lack of input from Dr. Jackson and the ICPOC will result in a long, resource-intensive process that takes away from the commission's current work and ultimately produces only formalities. It is clear that the ICPOC needs to be empowered in this moment, and I would love to see a resolution that more definitively does that.

Additionally, as a Michigan student, I would love to see a resolution that more definitively binds the council to defunding the Ann Arbor Police Department and re-funding human services. My Black peers have expressed fears over going about daily errands and enjoyment due to the threat of police brutality, here and in other cities in which they are temporarily residing for the summer. They should not have to be afraid anywhere. A commitment by the council before the semester would be a start toward alleviating those fears.

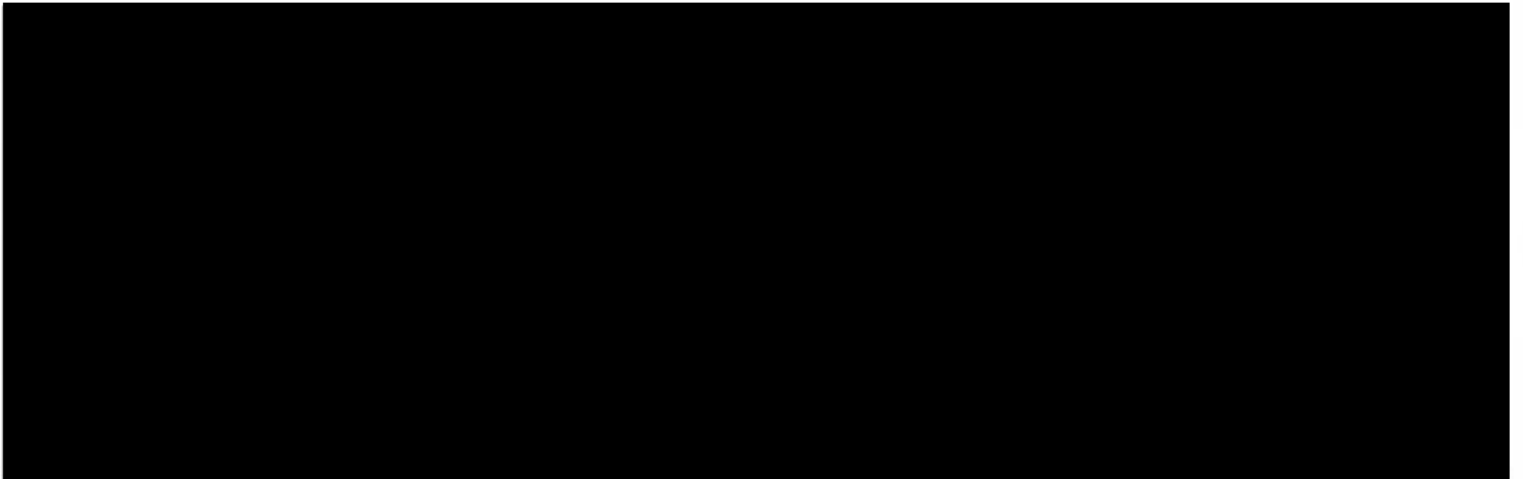

I have reached out to you several times, by telephone and email and I have not received any response from you. You and CM Ramlawi are our Ward 5 representatives on the Jackson Rd Sidewalk issue. CM Ramlawi has made time to respond and advocate on our behalf. I am perplexed as to why I have not heard back from you. Even Mayor Taylor has found time to listen to our concerns.

We need you to hear us and represent us. Here are our issues:

- The majority of affected Jackson Rd property owners **OBJECT** to the sidewalks and to the assessment
- To use **special assessments to fund city-driven sidewalk projects is questionable** at best. In order for special assessment to be applied, the property owner must especially benefit from the project.
- The assessments are **onerous**, whether in absolute numbers (\$52,000) or relative to the ability to pay. Among affected properties are Habitat of the Humanity supported homes. **Will you be able to sleep at night if these folks lose their homes over a sidewalk?**
- These residents are feeling railroaded. Given how fast this was pushed through during the Covid fear, they have the sense that the attempt was to slip this project in unnoticed. The process does not seem to be set up to protect property owners, but to take advantage of them.
- We are made up of immigrants, elderly and lower-income...please do not allow us to be neglected and discriminated against because our voices are not as powerful.

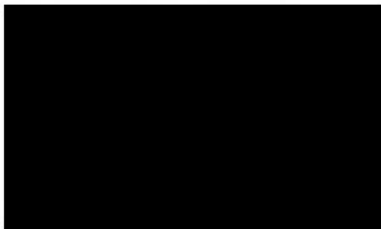

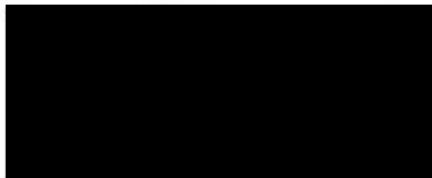
