To Whom It May Concern:

Simon Property Group, on behalf of Briarwood, LLC, is proposing to submit for an expansion of the mall, as well as the rezoning of the site from P----Parking to C2B----Business District. In following the requirements of the City of Ann Arbor's Citizen Participation Ordinances, (and meet the goals of Simon Property Group), adjacent property owners and interested parties are invited to attend a meeting to be held at the mall offices to discuss the impending plans for expansion of the mall. Simon Property Group requests your input into the project. All comments will be considered during the implementation of the project to the extent possible, and in the efforts of the Simon Property Group to be sensitive to the users of the mall and the adjacent property owners. All information gathered during this process will be summarized into a formal document by the mall management team, and will become a part of the formal submission to the City for Site Plan approval. The public attending the meeting will be able to provide verbal comments, which will be recorded by members of the team, or if you are unable to attend the meeting, your written comments will be accepted for a period of five (5) days after the date of the meeting, which is scheduled for August 15, 2013 at 5:00 pm at the mall conference room. Attendees should park near Pole 21 adjacent to the Von Maur entrance. Please see map on the reverse side for suggested parking areas.

The project proposes to build two new restaurants on the east side of the Macy's store, along with parking lot improvements, low energy LED parking lot lighting and providing water quality improvements to the storm water discharge from this portion of the Briarwood Mall site to Malletts Creek. The project will also provide landscaping enhancements to this area of the mall and pedestrian connectivity.

Simon Property Group intends to submit for site plan and rezoning approvals by Friday, August 26, 2013, with the goal of being heard at the Planning Commission meeting on October 15, 2013.

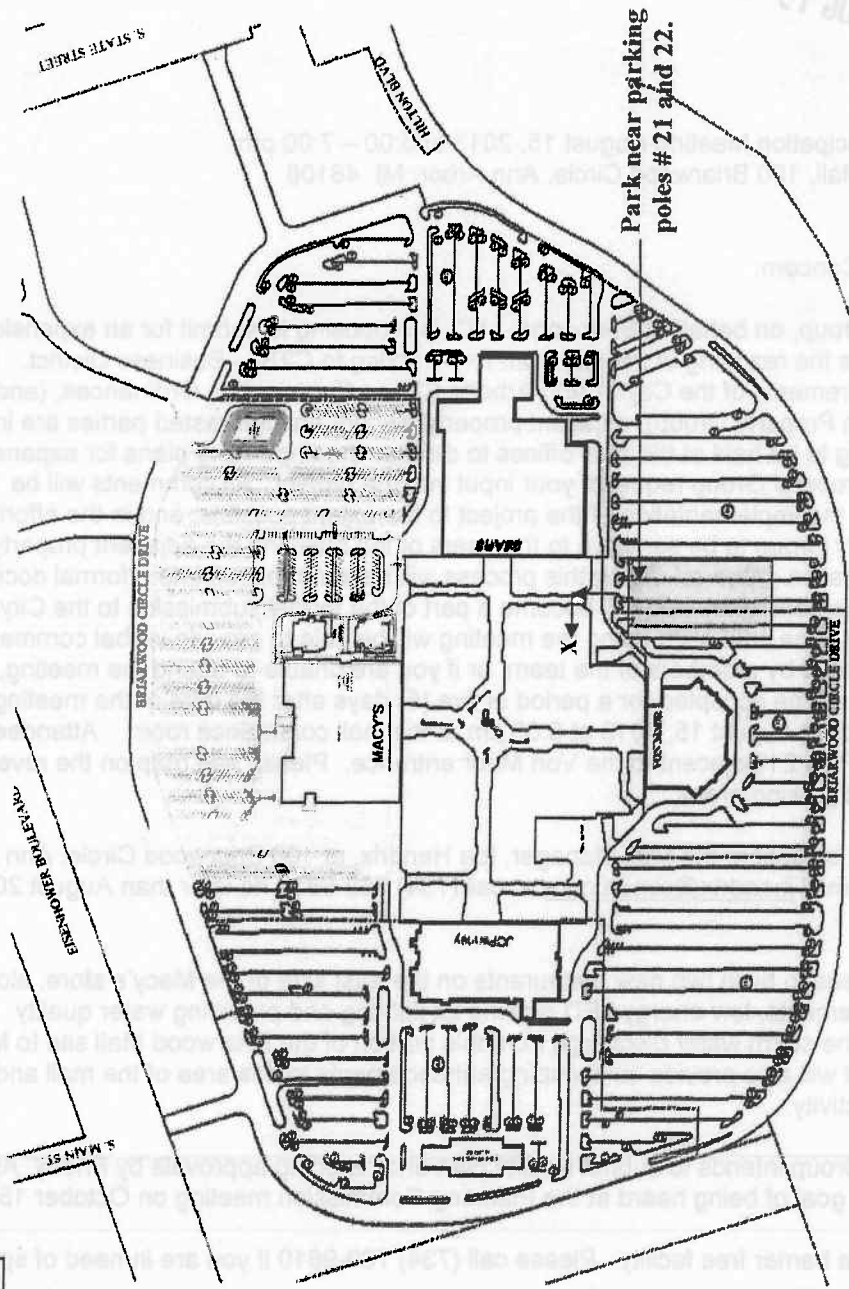

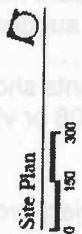
