Washtenaw County wishes to amend the contract with your agency. Corporation Counsel has indicated that this amendment could be accomplished by a letter signed by both of us. If this amendment is agreeable to you, please sign and return all copies of this letter. You will receive an executed copy of this letter upon completion.

Accordingly, I hereby amend the original Service Contract between Washtenaw County and City of Ann Arbor dated March 1, 2012, the Renewal Agreement dated July 27, 2017 and the Amendment dated 1/13/22 as follows:

Amend ARTICLE III – CHARGES FOR SERVICE to extend the contract as follows:

Beginning July 1, 2022, upon the above services and submission of invoices, the City of Ann Arbor will pay the County an amount not to exceed eight hundred fifty two thousand two hundred and thirty dollars (\$852,230) per year. Price will be set until June 30, 2023.

Amend ARTICLE IV – TERM to extend the contract as follows:

“This contract shall be in full force and effect for the term of one year commencing July 1, 2022 terminating on June 30, 2023.”

All other terms and conditions remain the same as in the original contract, subsequent amendments and any applicable RFP/RFQ.


