The Water Treatment Plant's filter press system was provided through Universal Filtration and Pumping Solutions (Universal F&PS) and remains the sole source vendor for this system since installation in the 1980s. The system includes two filter presses, each with hydraulically operated bomb bay doors to allow discharge of sludge. Filter press #1 bomb bay doors are original and have deteriorated beyond their useful life and are a safety concern. These doors must be specially fabricated and installed by a contractor familiar with this system. Northern Boiler and Mechanical Contractors, Inc. (Northern Boiler) is the contractor recommended by Universal F&PS to ensure proper fabrication and installation of filter press components. This work is the next phase after Northern Boiler successfully fabricated and replaced the doors for filter press #2 in FY22 making Northern Boiler the Best Source vendor for this work.

Additional value from continued use of Northern Boiler is the efficiency and cost effectiveness that comes from reuse of specific drawings developed by Northern Boiler for filter press #2 doors, as well as overall familiarity of the City's filter press system. Northern Boiler has been on site multiple times to take measurements and observe the operation of the bomb bay doors and are familiar with all the features that are required to complete this job. In FY22, Northern Boiler fabricated and installed a new set of doors below filter press #2.
