**Public Accuracy and Logic Testing of the Voting Equipment**

*Chief Deputy Clerk Stephen Gerhart was introduced to conduct the public testing of the voting equipment. Mr. Gerhart randomly selected the following precincts to be tested for the public test:*

*EV precinct 2-13 at EV site 5A  
EV precinct 5-52 at EV site 4B  
Election Day Precinct 4-39*

*Due to a technical machine error with EV5A, precinct 2-13 was tested at EV site 1A. It was explained to Election Commissioners and the public that the machine assigned to Early Vote site 5A would need vendor support and a new back-up machine would be used after a complete preliminary and accuracy test was conducted on the back-up unit.*
