ICPOC Officer Election

PSC Survey on Unarmed Response

L. Jackson discussed some of the background related to the exploration of the Unarmed Response Program in Ann Arbor. The consultation with Public Sector Consulting (PSC) involving community engagement process. Specifically, the Interim Report on Unarmed Police Resolution (Resolution R-21-129). The commission insisted that people who live, work and visit Ann Arbor be consulted, while paying attention to unhoused and college students. The current online survey does not reflect those communities. Therefore, the commission has decided to take three steps: L. Jackson and S. Carter will draft a communication to include with City Council Agenda Packet for October 3, 2022. L. Jackson and F. Todoro-Hargreaves will jointly address concerns at October's introduction to City Council. And the commission will discuss a Draft Resolution at October's meeting.

COMMUNICATIONS

NACOLE Annual Conference in Fort Worth, Texas: L. Jackson, S. Carter and C. Harrison reported on the new information they learned and the exciting people they met at the conference. L. Jackson encourage commissioners to participate in the ongoing NACOLE webinars to educate themselves on oversight.

S. Carter discussed the disturbing online supremacy organizations and any involvement within the Ann Arbor Police Department. Questioning how should the City respond to such a situation if it occurs? The commission suggested a policy should be drafted to address this issue with City Administration. CM Song gave some insight on Human Resources standards and conduct policy regarding discrimination.

M. Othman acknowledge the service and dedication former chair L. Jackson and CM A. Ramwali have given to ICPOC from it inception. The commission wishes them the best!
