#### 5-a. City Council

Councilmember Disch reported at the Monday, May 6, 2024 City Council meeting:

- -City Council approved UDC amendments for Multimodal Transportation Impact Analysis noting Council's emphasis for cyclist comfort and safety over congestion.
- -711 Church Street Rezoning Supplemental Regulations, Site Plan, and Development Agreement passed.
- -732 Packard Street PUD Zoning and Supplemental Regulations all passed on first Council reading.
- -City Council voted to put a charter amendment to prove sustainable energy utility on the ballot in November.

#### 5-b. Planning Manager

Deputy Planning Manager Hank Kelley noted there was nothing to report.

#### 5-c. Planning Commission Officers and Committees

Commissioner Abrons reported Ordinance Revision Committee met on April 23, 2024 and discussed a petition that has been submitted for five amendments for TC1 zoning district which includes curb cuts, modifying allowable building dimensions for larger sites, exceptions to minimum building project requirements, exemptions to use specific standards for parking structures and the proposed addition of a UDC definition for

"Block", noting items will be coming to the commission at the May 14, 2024 Working Session.

Chair Lee reported the Transportation Committee met on April 18, 2024, and reviewed their budget. The committee discussed Act 51 gas tax funding. Additionally, they had a discussion on the sidewalk construction millage and looked at the Main Street sidewalk upgrade from Ann-Arbor Saline Road to Stadium Boulevard. Chair Lee also noted that the Climate Action millage would go towards crosswalks, street lights, and bike lane upgrades. Furthermore, serious crash responses and some of the improvements seen around town were discussed. The East Medical Center Drive construction will continue until the end of 2024. MDOT indicated a willingness to add non-motorized connections along US-23, but that is still under discussion. Finally, the State and Hill improvements may be completed by August

**7-a.** Public Hearings Scheduled for Tuesday, May 21, 2024, Planning Commission Meeting

Deputy Planning Manager Kelley reported:

2270 Platt Rd Site Plan for Planning Commission Approval (SP23-0022) – A site plan to amend the approved Veridian at County Farm South Site Plan (file number Trakit-SP21-020) by redesigning buildings V, KK, L, M, CC-DD and EE-FF, increasing the total units from 110 to 121. Building locations generally remain the same while the types of buildings proposed and the number of units per building changes. The Veridian at County Farm South development has 110 approved dwelling units (proposed 121) in single-family, townhouse, and apartment buildings on a 363,945-square-foot (8 acres) site zoned Veridian at County Farm PUD (Planned Unit Development) district. The district is a mixed-income, mixed-housing type, sustainable neighborhood of up to 16 dwelling units per acre.

3310 Washtenaw - Site Plan for Planning Commission Approval (SP23-0017) — Proposed demolition of existing restaurant and construction of a new 5,240 square-foot restaurant building and 50 new parking spaces. Site is zoned C3 (Fringe Commercial); no drive through is proposed.

2862 Stone School Road Annexation and Zoning (AAPS-PROJ24-0001)

– Ann Arbor Public Schools initiated annexation of this vacant 2.65 acre
parcel from Pittsfield Township and rezoning to PL (Public Land).

3801 Stone School Annexation and Zoning (AAPS-PROJ24-0002) – Ann Arbor Public Schools initiated annexation of this vacant 3.0 acre parcel from Pittsfield Township and rezoning to PL (Public Land).

# **10-a.** 24-0821 1146 South Maple Road Planned Unit Development (PUD) Pre-Application Conference

Hickory Way III is a proposed 4-story, 39-unit Permanent Supportive Housing building by Avalon Housing. It will meet National Green Building Standards, have 15% barrier-free units, and provide 700 square feet of community space. The project proposes to annex 1146 South Maple from Scio Township and rezone to a PUD. It will be adjacent to the existing Hickory Way I & II buildings and surrounded by multi-family residential and Hansen Nature Area, a city park.
