Hi Mayor Taylor,

This email is to inform you that Ann Arbor will be included in the eleventh edition of the Human Rights Campaign's Municipal Equality Index (MEI). The Human Rights Campaign (HRC) is the largest civil rights organization working to achieve equality for lesbian, gay, bisexual, transgender and queer (LGBTQ+) Americans. The MEI is the first nationwide evaluation of municipal laws, policies, and services affecting the LGBTQ+ community.

This year, HRC will evaluate the 506 cities rated in last year's publication. These include the 50 state capitals, the 200 largest cities in the country, the five largest cities in each state, the cities home to the state's two largest public universities, 75 cities and census-designated places with high proportions of same-sex couples, and 98 cities selected by HRC and Equality Federation group members and supporters.

At this time, we are writing simply to alert you that Ann Arbor will be rated again this year. The [2022 MEI standards for credit](#) have remained the same as last year. Please review the 2022 MEI template scorecard attached to this email because the format has changed from previous years. Certified mail will be sent to the mayor and city manager's office to notify them of this email. If there is a specific person in your office you would like us to communicate with from now on, please let us know by emailing mei@hrc.org.

HRC will conduct preliminary research on Ann Arbor and will send you a draft scorecard to the email addresses we have on file in June for your review. When you receive your draft scorecard, we ask that you review our research and contact us with corrections and supporting documentation before **Friday, July 29**.



Dear Mr. Dohoney, all,

I am interested in bringing a resolution to council to start the process of creating a new zoning designation designed to allow for new types of housing in our community. The goal would be to allow for, in limited or emergency circumstances, **Temporary, Transitional and/or Tiny Houses**. I picture something like R7, one step beyond a mobile home park district, but allowed to be applied where appropriate either as an accessory use or a supplemental use, or stand alone as lot characteristics permit.

Examples of structures that might exist in R7 include Pallet Houses, Tiny Houses, or Emergency Structures like tents. One characteristic they all have in common is that the majority of these structures do not have fixed foundations, plumbing, HVAC or electrical components. I do not know if this should include mobile campers, camper vans or the like. There is a need in our community for this type of housing – housing first needs can be met by temporary shelters of this type, but we are not allowed to deploy them, as no zoning designation exists for them. I seek to remedy this with “R7”.

RESOLUTION TO CITY COUNCIL REGARDING ANN ARBOR TRAFFIC TRANSPARENCY

Whereas, the City of Ann Arbor has charged the Independent Community Police Oversight Commission (ICPOC) with oversight of AAPD services and review of AAPD incidents;

Whereas, it is the mission of ICPOC to establish and enhance communication and sharing of information between the AAPD and the community;

Whereas, it is the mission of ICPOC to build mutual trust between the community and AAPD;

Whereas, the Ann Arbor community relies upon ICPOC, as an independent arbiter, to ensure transparency and accountability by providing the public with thorough, accurate information regarding policing and its impacts on public safety;

Whereas, the transparency of traffic stop data can provide the Ann Arbor community with essential information about transportation safety, policing practices, and provide the AAPD with necessary data to effectively evaluate and improve the quality of services it provides;

Whereas, these data are currently being collected and have been sent to ICPOC in the past.

Whereas there are civil rights, transportation safety and policing issues, these data are relevant to the Human Rights Commission, to the Transportation Commission and to the Independent Community Police Oversight Commission.

Resolved, the Independent Community Police Oversight Commission requests that the Ann Arbor Police Department (AAPD) shall continue to record information relevant to each vehicle stop performed by AAPD into an electronic database;

Resolved, the Independent Community Police Oversight Commission requests the development of an ordinance from the City of Ann Arbor within 4 months from the date of this resolution to require the maintenance and reporting of information related to vehicle stops with the following provisions:

- Within six (6) months of the effective date of such an ordinance, the AAPD shall report this information quarterly to the ICPOC by police service area:
- The date, time, duration and GIS location of all stops
- The area to which the police officer was assigned at the time of the stop
- The reason for the stop
- The year, make and model of the vehicle
- The driver's perceived ethnicity and gender identity
- The number and ethnicity of passengers, if any
- Any police action taken, including but not limited to whether a warning or citation was issued

- Specific citations, if issued
- Whether any occupant was frisked or searched
- Whether the vehicle was frisked or searched
- Whether consent to search was sought, and if so, whether it was provided
- Whether any occupant was arrested, and if so, any and all charges
- Whether the vehicle stop resulted in recovery of contraband, delineated by specific type
- A unique identifying number of the officer
- Any other relevant information necessary for effective monitoring and oversight of traffic stops.
- The Ann Arbor police department shall not report the name, address, social security number, driver's license number or other unique personal identifying information of persons stopped, searched, or subjected to a property seizure, for purposes of this section.
- Notwithstanding any other law, the data reported shall be available to the public.

Resolved, the Independent Community Police Oversight Commission requests that the AAPD develop procedures and policies to reasonably ensure that information in the database is complete and accurate.

Resolved, the Independent Community Police Oversight Commission requests that the AAPD regularly collaborate with the Independent Community Police Oversight Commission to ensure nationally recognized best practices are implemented to mitigate bias and disparity in vehicle stops and in the use of evolving technologies that may perpetuate racial bias.

Resolved, the Independent Community Police Oversight Commission requests that the AAPD transmit an annual report detailing AAPD enforcement of such an ordinance and identifying any best-practices policy changes that were implemented over the preceding year to the Chairs of the Independent Community Police Oversight Commission, the Human Rights Commission and the Transportation Commission.

Hi Mark and Travis,

I'm following up on the house fire incident (we are referring to it as arson, as do our neighbors) on Gladstone. Mark, we appreciated your visit and discussion with us at our home. Mark and Travis, we appreciate you organizing the community meeting on March 28. But we are reaching out to you again as everyone we speak to in the neighborhood is now more troubled than ever as we have heard nothing - emphasize nothing - from the police department about the case since the community meeting on March 28. We believe the neighbors grudgingly understood why little new information was able to be shared at that meeting, but now it seems as if this incident has simply vanished from the radar. We can tell you with certainty that the incident has not vanished from our neighbors' radar as we are asked for news about the incident multiple times each week.

We are attempting to figure out next steps. If in fact there is little to no likelihood of charges being brought in this case, then we think the police department owes it to the community to simply say so. While this may result in uncomfortable questions, at least the community will know the status of things and we can plan for additional steps to protect the neighborhood from similar instances in the future.

Travis and Mark, what do you recommend as next steps? We are convinced that simply not communicating is not what is needed right now.
