Attention Ann Arbor Planning Commission,

The acceptance by your commission for Sartorius Biotech to build a brand new, 130,000sf building that heats with natural gas presents the clear image of hypocrisy towards any intent to meet the goals of the A2Zero climate plan.

Even though the Planning Commission has not yet established a timeline for meeting A2Zero goals, it's <u>obvious</u> that permitting this building's construction under current plans will be a hinderance towards meeting those goals. Modifying this building to meet emissions reduction requirements after construction will cost Sartorius far more than originally including geothermal now. Plus the sunk costs under the current plan to use natural gas will never be recovered. By allowing this building to proceed as currently specified, without a serious and sincere push towards alternatives, will be a disservice to both Sartorius and our community that will be working hard to meet our obligations.

Allowing construction to proceed without a shift to more efficient heating alternatives, such as geothermal, will not only make it more difficult to achieve A2Zero goals, it will:

- reduce confidence that A2Zero is a climate action plan that should be taken seriously, and
- establish a precedence for other construction plans to follow that it's okay for new construction to heat with fossil fuels.

Certainly, there must be some way under the Commission's authority to make it clear to Sartorius and it's developer that the community expects its business leaders to take all reasonable steps to fight climate change in general and meet the goals of A2Zero specifically, <u>especially when there are feasible</u> options available to do so.
