There is community push back, they are not agreeing with their configurations. There were other presentations and a discussion of the Annual Report. What to do with American Rescue Program Funds? Tribute to a commissioner who passed away, Linda Diane Felt, former Chair. This months discussion is on the Policy Agenda and what they want to push for on the state level and discuss taking over some roads from MDOT. T. Hull is not planning to apply for reappointment in May and encourages any commissioners interested in replacing him as Transportation Liaison please notify him or*

**U OF M COUNCIL FOR DISABILITY CONCERNS MEETING UPDATE - KATHLEEN MOZAK**

*K. Mozak provided an update on the Council on Disability Concerns. A new chair has been announced Pam McGinty. They have not settled on a single chair position, still talk about a co-chair in the future. They plan to focus on avocation work for the next year, looking to improve parking availability on campus, year round and snow removal. There is also a focus to ensure individuals who are deaf and hard of hearing be able to get masking accommodations. Plans to continue to support the Neubacher Award winner, Vincent Pinti and to expand the PCA accessibility for students and other U of M members. Continue to collaborate with existing partners and expand to new relationships. Work with Ashley Wiseman to improve mapping disability inclusion, a prototype of searchable database of individual groups related to disability issues.*
