Dockless Bike and Scooter Discussion (LINDA DIANE FELDT & SCOTT TRUDEAU)

Citizen Input and Process for City Street-Related Improvement Projects (R-18-275)(RAYMOND HESS)

Staff provided a draft response to R-18-275 for consultation with the Transportation Commission.

Commission comments included the following:

- *Maple Road Lane Reduction – Concern that this is an example of bad communications -residents were asked for feedback after the fact rather than consulted ahead of time.*
- *AAPS Coordination –Concern that the process for AAPS-initiated projects is not clear.*
- *Traffic volume peak hour data – Request that staff provide Council additional materials not requested such as the number of vulnerable users in an area and 85th percentile speed to better illustrate the conditions during off-peak hours and the challenges for pedestrians and cyclists.*
