*Identifying LGBTQ+ Human Rights Needs: S. Peitzmeier shared that she*

*is waiting for a response from City Council Members regarding gender-neutral bathrooms and ways to protect gender affirming care and reproductive health. The City will have additional discussions before deciding on any recommendations. More information and details to come.*

*Contractor Compliance: P. Meadows presented the contractor spreadsheet of all the current contractors with the City of Ann Arbor. P.Meadows shared that moving forward the Office of Organization Equity will be responsible for City contractors compliancne with the Non-Discrimination Ordinance reporting.
