TreeTown Murals to install murals at Huron St near Delonis Center and N Main at M14; Peter Allen & Assoc commissioned the restoration the murals with funding and interest in the current works. Work on wing walls and concrete and metal overpass. Fund raising and reached half of the goal of \$250k from Larry and Lucy Nissen, Peter Allen & Assoc and Destination Ann Arbor along with Constellate Consulting in New York. REPORT FROM STAFF

Welcome Ward 1 Council Member Cynthia Harrison. Council Member Harrison was born and raised in Ann Arbor; she is a wife, a mother and a community program manager at the Ann Arbor Center for Independent Living; where she works to empower reentering citizens. Cynthia brings an art background as a singer and lettered in choir and selected the Art Commission due because of her passion for the arts.

Legal team working with staff on the ARPA funding to determine next steps as no bids were received. Staff reviewing the possibility of an outside agency administering the program.

Hillary Hanzel, Park Planner for the Parks Department and Peter Sanderson, Park Planner for Washtenaw County Parks collaborate and present two projects today.
