He explained that the Brownfield Committee at the county level has the ability to evaluate TIFs, noting that TIFs are "but for" projects, meaning that the project could not proceed but for assistance through the financing.

Deputy Planning Manager Kelley additionally shared that the Planning Commission role for TIFs will simply be awareness of their association with a given petition. Brownfield requests proceed directly to City Council before advancing to the County.
