Subject: Follow Up on Our Check In

Councilmembers Hayner and Disch,

I wanted to follow up on some items you inquired about during our check in on April 13.

- Status of Broadway neighborhood – road and water main - Broadway from Plymouth to Plymouth is scheduled for construction this year. Plans are scheduled to go out bid this month. A public meeting will be scheduled for the project soon.
- Old Fourth ward – Kingsley & Kerrytown – road condition – Kingsley is currently scheduled for 2024 in conjunction with a watermain project. Staff is currently working on another publicly accessible dashboard to show upcoming road projects for several years out, and this will be shared once it is ready.
- Hilldale and Brede Place, adjacent to Barton – road condition - Based on the latest condition ratings both Brede Pl and Hilldale Dr are candidates for street resurfacing; however, they are outside the primary work areas identified in the current Local Street Resurfacing Program Plan that extends through calendar year 2025. There is a strong possibility that the Resurfacing Program could be focusing on this area in 2026, or it is possible it could be addressed sooner as part of a Road Bond. Staff are currently working on identifying the additional projects that will be completed using these funds. Once the schedule is complete it will be shared with Council.

Thank you for the opportunity to connect and for sharing your concerns and priorities. I look forward to our next meeting.
