**NOTICE OF PUBLIC HEARINGS  
2670 & 2690 ANN ARBOR-SALINE  
ROAD REZONING  
(2670 & 2690 ANN ARBOR-SALINE  
ROAD)**

The Ann Arbor City Council will conduct a public hearing at 7:00 p.m., Monday, September 18, 2023, in the City Hall Council Chamber, 2nd floor of the Guy C. Larcom, Jr. Municipal Building, 301 E. Huron Street, Ann Arbor, to hear all those interested in the proposed Ordinance No. ORD-23-27 – 2670 & 2690 Ann Arbor-Saline Road Rezoning. The ordinance would rezone 1.542 Acres from R1C (Single-Family Dwelling District) to O (Office District,) 2670 & 2690 Ann Arbor-Saline Road Rezoning at 2670 & 2690 Ann Arbor-Saline Road.

The proposed ordinance would amend the City Zoning Map, which is a part of Section 5.10.2 of Chapter 55, Title V of the Ann Arbor City Code.

Section 1, THE ZONING MAP, which, by Section 5.10.2 of Chapter 55 of Title V of the Code of the City of Ann Arbor is made a part of said Chapter 55, shall be so amended as to designate the zoning classification of property described as follows:
