*An international graduate student spoke in support, speaking of the challenges of finding housing from abroad.*

*A Ward 3 resident spoke in support.*

*An employee of the University of Michigan spoke in support, stating it is a human rights issue.*

*A renter named Tara spoke in opposition of an opt-out clause.*

*Adam Jaskiewicz, resident, spoke in support of the ordinance and expressed opposition to a carve-out clause.*

*Elliott Branden, member of the faith community*

*A graduate student spoke in support.*

*Michael, a Ward 3 resident, spoke in support and stated his opposition to an amendment allowing tenants to waive their rights.*

*Jen Lamberth, a landlord, stated the proposed ordinance does not align with the dates for housing contracts with UM.*

*Trische Duckworth, resident, spoke in support.*

*An unidentified renter spoke in support.*

*A local landlord spoke in opposition, stating there is not currently a housing shortage.*

*Melissa, a Ward 5 resident, spoke in support.*
