- 1. Allan Newman - Support of Rising Hope for Housing in Regards to the FY25 Budget (INT-2) (in person)**

Allan Newman, Board Member of Avalon Housing, spoke in support of Rising Hope for Housing programs and asked for support for the programs in the upcoming City budget.

2. Brian Geiringer - A2ZERO and the Phase 2 Feasibility Study in the FY25 Budget (INT-2) (in person)

Brian Geiringer, Ypsilanti resident, spoke about Ann Arbor for Public Power and his role in the organization. He urged Ann Arbor to move to municipal power.

3. Adam Grant - Funding for Rising Hope for Housing and the FY25 Budget (INT-2) (in person)

Adam Grant, resident of Lansing, urged Council to support the Rising Hope for Housing program in the FY25 budget.

4. Matt Bossart - Proposed Question for SEU (in person)

Matt Bossart, resident and PhD student, spoke about the proposed plans for an SEU and a municipal-owned utility. He expressed opposition to the proposed City Charter amendment language as written.

5. Karl Barton - Non-Agenda Item (in person)

Karl Barton, resident, was not present.

6. Henry Herskovitz - Holocaust Education in AAPS (in person)

Henry Herskovitz, resident, spoke about the Holocaust education taking place in the public schools.

7. Roger Kerson - Municipal Electric Utility (in person)

Roger Kerson, resident, spoke about a proposed municipal-owned utility in the City.

8. Marisa Mercurio - Sustainable Energy Utility (SEU) (phone)

Marisa Mercurio, resident, spoke in support of a municipal-owned utility. She stated the current proposed City Charter amendment is not acceptable to supporters.

9. Milton Baker - SEU Ballot Proposal (in person)

Milton Baker, resident, spoke about the proposed City Charter amendment for an SEU. He expressed concern about the proposed amendment prohibiting an MEU.

10. Kathy Griswold - Dangerous Conditions Due to Overgrown Vegetation at School Crosswalks (in person)

Kathy Griswold, resident, was not present.

11. Greg Woodring - Comments Related to Public Power (in person)

Greg Woodring, resident of Ypsilanti, stated he was excited to see the Phase 2 Study in the City's FY25 budget. He also talked about the City Charter amendment language, stating the Ann Arbor for Public Power group wants to be able to support the amendment, but currently have concerns with the proposed language.

12. John Walker - Rising Hope for Housing Project (in person)

John Walker, resident, spoke about A Brighter Way, an organization that supports returning citizens. He urged Council to continue to support Rising Hope for Housing projects.

13. Margaret Goodly - Proposed Development at 2525 Ann Arbor-Saline Rd. (phone)

Margaret Goodly, resident, spoke in opposition to the proposed rezoning of 2525 Ann Arbor Saline Road. She asked Council to vote no on this rezoning due to traffic congestion in the area.

14. James Osborn - City Composting Yard and Website (in person)

James Osborn, resident, thanked Council for waiving the drop-off fees at the compost station after a storm in 2023. He wanted Council to know that the website regarding compost drop-off is misleading and out-of-date. He previously asked staff to update the information and after one year, it still has not been updated. He stated he does enjoy City Parks.

15. Mozghan Savabieasfahani - We Are Against Military Aid to Israel (in person)

Mozghan Savabieasfahani, resident, spoke about her campaign for Ann Arbor City Council Ward 4. She also urged Council to support a resolution opposing military aid to Israel.

16. Blaine Coleman - We Are Against Military Aid to Israel (in person)

Blaine Coleman, resident, urged Council to support a resolution against military aid to Israel.

17. Ellen Johnson - Gas-Powered Leaf Blowers (in person)

Ellen Johnson, resident and member of the Pittsfield Village Condominium Association, spoke in favor of the ordinance banning gas-powered leaf blowers. However, she stated implementation and costs associated with the ordinance need to be addressed, suggesting a variance for small businesses.
