Hello my name is Jennie Baez im 55 yrs old im riddled with osteoarthritis I have asthma and now im blind.

I am in the Delonis recuperative care program. I came here from Kalamazoo to have a very hard eye surgery. I went blind back in march and the only place to have my surgery was here at the Kellogg eye center.

I have been homeless for 2yrs, in that time I have been beaten, rapped, been put in jail for nothing, slept on concrete stoops pushed shopping carts slept in the park bench while getting snowed on in -3 \* weather etc! I was finally given my section 8 voucher but it came in march at the same time I went blind. I have been trying to heal from this surgery and in June I suffered a stoke which cased severe paralysis to my face and arm.

Well to make this story short when I came here back in May to have surgery I was promised by Delonis shelter that they would handle my paperwork for my section 8 voucher that I already had and it would be taken care of so I wouldn't loose it. They were supposed to file for extensions and a suspension of my voucher because I have been under the care of the university since may the 3rd. Well guess what! No one took care of it and now they have lost my voucher, it was cancelled the 12 of July! The staff of Delonis came to me last week Monday to tell me what had happened and they were sorry and now I have to get out of the room I have been in since I got here because now they cant help me anymore because I no longer have a voucher so oh well now I have to get out of the room where I have resided since may on this Thursday. ALSO one of the rules that I was told when I got here was I would be given a 2 week notice to move yet they are telling me today 9/6 and expect me to move 9/8 and im disabled?! They did the same to another man who had his leg cut off and he has been robbed and beaten since he was thrown out of here. Delonis said they would give us help and they have given false hope and not their job. Im not from here, im not from ann arbor and now im being kicked out half blind into the street because now they cant help me anymore! Not to mention due to the fact I had the stroke my eye surgery did not heal the right way and now I have to have more surgery but I guess I will pop a tent in the park and have my surgery. I am by no means stupid or uneducated and I will not be cast aside when someone else has dropped the ball on me. And I am not going to let this go swept under a carpet because since I have been here in this program they have messed up quite a bit since I have been here. And they have just said oh well, but others don't stick up because they are afraid they don't want to loose what little they have. They say no one listens or cares! Well that is not a good enough answer for me and I will not be swept under the carpet.

I need my voucher back and someone has to hear me because im going to have another stroke from all this stress. Im sending this letter out to everyone I can because im not the only one who needs help im the one who is reaching out.

Tuesday Sept 6, 4pm

Jeff Watson, head of the DDA, just came by to talk with myself and a manager here, Matt Banks. Here is my recap of the conversation.

- Jeff tried to argue that they did give us notice of the project. He said it was being talked about a year or so ago. But he could not point to any communication in the recent past that said when the project was set to begin, but had a vague recollection that "staff had notified us." (As an aside, neither Grace Singleton -- of Zingerman's and head of the Kerrytown District Association -- nor Diana of Thistle and Bess -- had any more notice than we had.) I challenged him to provide an email to prove his point. I am quite sure none exists.
- Jeff basically said there is nothing that he can do. He acted like we should be grateful for the "improvement." And that by being obstructionist, I'm prolonging the project and driving up the price tag.
- At one point I mentioned that the project caused us to lose about \$4k in sales last week (a very conservative estimate). and he said: "well, you should file a claim for compensation." When I asked about the process for that, he admitted there is no process.
- Jeff tried to argue that there was no dust being produced by the project. I showed him the video of the dust cloud rolling toward us and he seemed surprised.
- Jeff said there is no way they can change the hours during which heavy work happens. I challenged that and he admitted he hadn't spoken to Fonson (the contractor) about it. He said he would call.
- At the end of the conversation I said: I thought you were coming to this meeting with \*something\* for us -- some sort of compromise but it seems like you're not. Do you have \*anything\* to offer? To which he responded no, he did not have anything to offer, but that he would call the contractor and give him two days to respond.

Honestly Matthew, the meeting was a complete waste of time. Jeff is not knowledgeable, not caring, not creative, and completely unconcerned with the welfare of my business. When he was talking about "improvements" I said: look at this place. My restaurant IS an improvement. If we can't stay in business here, it will do more harm to the neighborhood than not having a buffered bike lane. We asked him the price tag of the project. He said he didn't know but thought it was something like \$2.1 million. I said that if they would reimburse us \$4k/week in lost sales through the project, that would be a drop in the bucket. The DDA can better handle the cost than a small restaurant can. He appeared completely unimpressed and uninterested.

At the end, I said: well, I guess there's no compromise here. You have your interests and I have mine and I've retained legal representation. He said: give me two days.

So that's where things stand.

Do you have any suggested next steps?

I will be out of town at a wedding Thurs -Sun this week, but will stay in contact with staff as this situation unfolds.
