PROPOSED PLANNING COMMISSION MOTION

RESOLVED, That the Ann Arbor City Planning Commission hereby approves the "City of Ann Arbor Master Plan Resolution" and the "City of Ann Arbor Resource Information In Support Of The City Master Plan Resolution."

STAFF RECOMMENDATION

Staff recommends **postponing** the motion to allow the Commission to consider comments provided at the public hearing and to establish its work program priorities. The work program priorities will be discussed at the June 14th Work Session.

STAFF REPORT

Article III of the Ann Arbor City Planning Commission Bylaws requires Commission review of the Master Plan each May. The purpose of the review is to identify policies that may need to be studied for possible change or new policies that should be added to the Master Plan. A public hearing has been scheduled for the May 17th meeting to allow citizens the opportunity to suggest changes.

State law requires that the Master Plan be evaluated for updating at least every five years. The Master Plan resolution adopted in July 2015 anticipated that staff and Commission members would continue to assist in identifying a locally preferred alternative for the Connector high capacity transit route; continue to assist in the implementation of the Sustainability Action Plan; continue to assist in the implementation of the Washtenaw County Affordability and Economic Equity Analysis recommendations, in coordination with the Energy Commission, the Environmental Commission, Park Advisory Commission, Housing Commission and Housing and Human Services Board (ADU); begin the process of developing a greenway plan for Allen Creek; and begin the updated land use recommendations for the North Main Street corridor. All items listed above except the North Main Street corridor, are in process or have been completed. The North Main Street corridor land use recommendations have been delayed, and are proposed to be moved forward to the next fiscal year.

Continued master plan items identified for FY2016 include working with the Connector Study project team to identify a locally preferred alternative for the high capacity transit route; assisting in the implementation of the Sustainability Action Plan, and assisting in the implementation of the Washtenaw County Affordability and Economic Equity Analysis.

New items identified in the attached FY2016 Master Plan resolution include continued work on the Allen Creek Greenway; begin the process of updating land use recommendations for the North Main Street corridor; and review the Parks and Recreation Open Space Plan Update as an amendment to the Master Plan.

Attached is a draft resolution that reaffirms the existing master plan elements and identifies the master plan updates underway, in addition to a resolution identifying resource documents that support the master plan.

We recommend that the Planning Commission hold the public hearing on May 17, 2016; however hold off adopting attached resolutions until the June 21st meeting, which will be after the Planning Commission discusses the FY 2016-2017 work program. We have scheduled the work program for the June 14th CPC work session.
