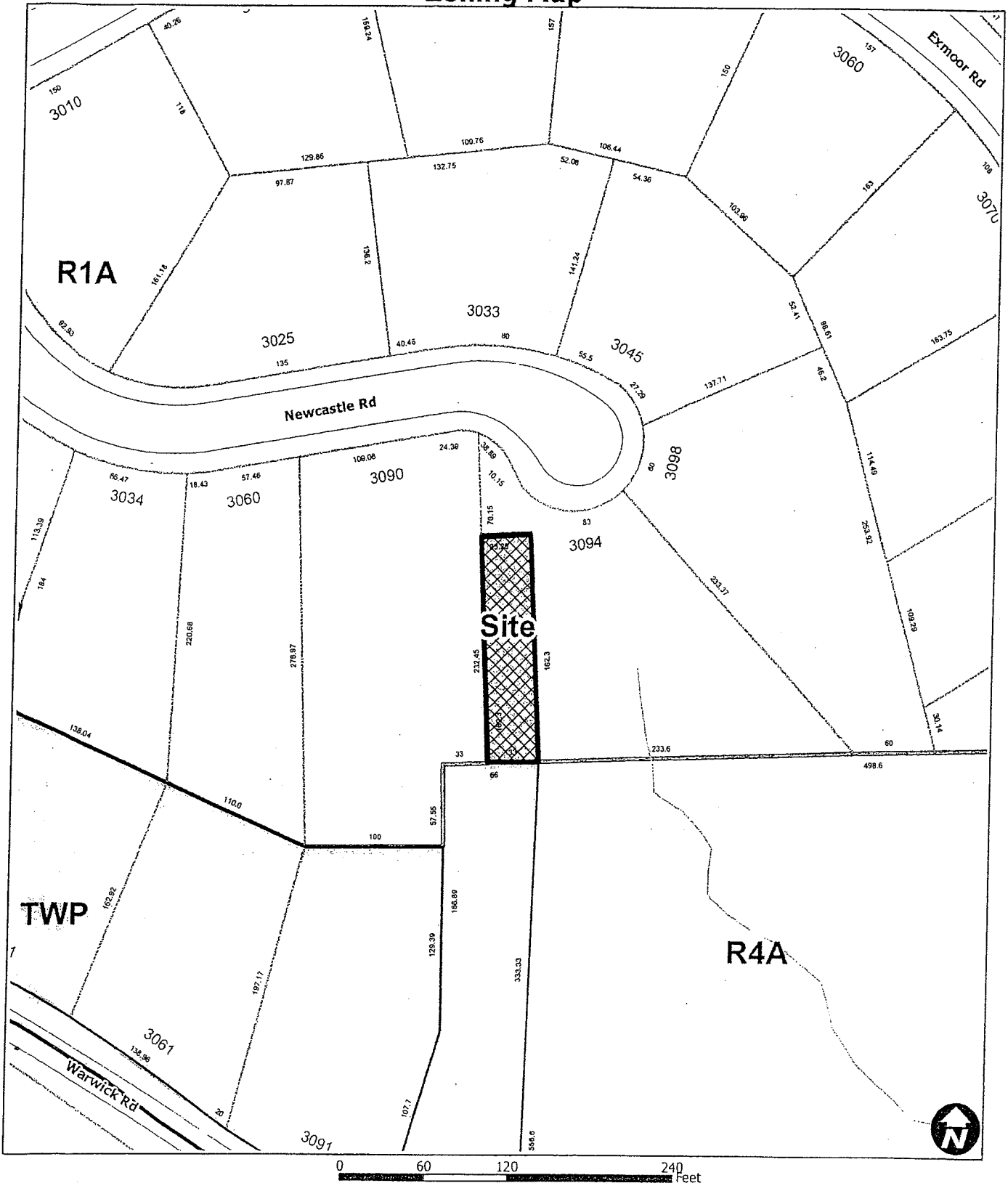

Land in the Southwest ¼ of Section 35, Town 2 South, Range 6 East, Ann Arbor Township, Washtenaw County, Michigan, described as beginning at the Southwest corner of Lot 44 of "Woodhaven Hills" according to the plat thereof as recorded in Liber 15 of Plats, Pages 31 and 32, Washtenaw County Records; thence N 01°11'29" W 162.30 feet (previously described as N 01°07' W) along the West line of said Lot 44; thence S 88°58'06" W 33.00 feet (previously described as S 81°25' W 33.28 feet); thence S 01°11'29" E 162.30 feet (previously described as S 01°07' E); thence N 88°58'06" E 33.00 feet (previously described as N 88°10'30" E) to the Point of Beginning. Said Parcel B containing 0.123 acres, more or less.
