No Turn on Red Downtown

Councilmember Briggs has introduced a draft resolution for Transportation Commission's consideration which would prohibit vehicles from turning on red in downtown Ann Arbor. Traffic Calming Committee Charter

At the last meeting, the Transportation Commission agreed to establish a Traffic Calming Committee and Commissioners Kleinman, Briggs, and Smith volunteered to serve in this capacity. It has been standard practice for the Transportation Commission to approve a charter which outlines the charge of its Committees. Safe Streets For All Grant Application

A new discretionary grant application focused on vision zero and transportation safety was recently released by the US Department of Transportation

(<u>https://www.transportation.gov/grants/SS4A</u>). With the City's "Moving Together Towards Vision Zero" Transportation Master Plan, the City seems well positioned to submit an implementation application for systemwide transportation safety improvements in Ann Arbor. Included in the packet is a draft Council resolution on which staff seeks a recommendation from the Transportation Commission.



Proposed action: Recommend approval of the resolution to submit the Safe Streets For All Grant application

Capital Improvement Plan Update

Ordinance and Bylaws Amendment

As per the enabling ordinance and bylaws, the composition of the Transportation Commission includes "one owner or operator of a transportation business operating in Ann Arbor." Finding someone who fits this requirement and has interest/capacity to serve on the Transportation Commission has proven difficult in the past. At the Chair's recommendation, staff has prepared an ordinance revision and complimentary bylaws amendment which would delete this member in favor of adding an additional "member of the public" (for a total of 7). Bylaws amendments require deliberation at two Transportation Commission meetings before it can be approved so no action can be taken by the Transportation Commission on this item until the September meeting.
