OLD BUSINESS

Annual Renewals - Status of Staff Reviews

Mary Fales, Assistant City Attorney, updated the committee on the liquor license annual renewal process. Departments are working on updating their analysis processes. The next step in the process is to create letters to send to businesses. The letter would consist of identifying violations. Lyn Badalamenti in the City Clerk's office prepared a first draft of the letters for the commission to review.

(Councilmember Derezinski arrived at 3:53 p.m.)

Councilmember Anglin said that the renewal letter for 2010 should explain this process and what the City would be looking for in the 2011 review. It was also suggested that the ordinance be included with the renewal letters, so that businesses know exactly how the ordinance reads.

The committee narrowed the three proposed letters down to two; the letter one that had no objections and the letter that lists the reasons why the application was not approved (Letter 3). Letters should be sent to those businesses without objections, as indicated on the list presented at the meeting.

Sgt. Pfannes of the Ann Arbor Police Department said that MLCC is automatically notified of any liquor violations. The department looks at calls for service violations, determines if the activity is done by the bar or patrons at the bar, and a case is built from there. There are normally approximately 10 establishments per year with liquor violations. Sgt. Pfannes stated that the most common MLCC violations are selling to minors and fighting in the bar. There are other MLCC violations, but these are the common ones.

The committee asked that Police staff keep track of violations annually.
