

**CITY OF ANN ARBOR
AMENDMENT NUMBER 1 TO THE
PROFESSIONAL SERVICES
AGREEMENT BETWEEN
BAKER AND ASSOCIATES
AND THE CITY OF ANN ARBOR FOR
2024-2025 BRIDGE INSPECTION PROGRAM, RFP 24-35**

This Amendment Number 1 ("Amendment") is to the agreement between the City of Ann Arbor, ("City") and Baker and Associates, ("Contractor") for Professional Services Agreement (PSA) which is dated 9-19-2024 ("Agreement"). City and Contractor agree to amend the Agreement as follows:

1. Article V. Compensation of Contractor is amended to read as follows:

The Contractor shall be paid in the manner set forth in Exhibit B2. Payment shall be made monthly, unless another payment term is specified in Exhibit B2, following receipt of invoices submitted by the Contractor, and approved by the Contract Administrator.

2. The attached Exhibit B2 supersedes and replaces the previous Exhibit B.


All terms, conditions, and provisions of the Agreement, unless specifically amended above, shall apply to this Amendment and are made a part of this Amendment as though expressly rewritten, incorporated, and included herein.

City and Contractor agree that for this Amendment and any documents related to the Agreement: 1) signatures may be delivered electronically in lieu of an original signature; 2) to treat electronic signatures as original signatures that bind them; and 3) signatures may be executed and delivered by facsimile and upon such delivery, the facsimile signature will be deemed to have the same effect as if the original signature had been delivered to the other party.

This Amendment to the Agreement shall be binding on the Parties' heirs, successors, and assigns.






