Dykema assists the MACT Executive committee and the MACT legislative committee on areas of public finance and administration of the General Property Tax Act (PA 123). The MACT focuses their efforts on educating policy makers and advocating for legislation that addresses foreclosures, foreclosure prevention, property taxes, property tax reform, and the administration of delinquent taxes. Lobbying on legislative matters involves issues that affect virtually every aspect of the universities' enterprises. A primary focus is on advocating and securing increased state investments in institutional operating support, state financial aid programs, and campus capital outlay projects. This complex engagement is very much a collaborative effort that requires Dykema to provide strategic and tactical counsel to best leverage the unique relationships the universities have with various legislators and other stakeholders throughout the state.

As a newer organization, Dykema has increased GLWA's relationships within the Michigan legislature, the Governor's administration, state departments, and related organizations. On behalf of GLWA, Dykema has advocated and engaged the Michigan legislature on PFAS drinking water standards, state funding to support water affordability, water infrastructure, and Covid-19 legislation. Dykema has engaged with government influencers to ensure that water and wastewater employees were included as frontline workers in Covid-19 legislation and Executive Orders. It was imperative to ensure that the legislation was inclusive to allow GLWA to have adequate manpower to continue to offer services during the pandemic. Most recently, Dykema has engaged the Michigan Legislature on behalf of GLWA to secure federal ARPA relief funds to support water/wastewater infrastructure within their service area. Currently, GLWA has been allotted \$400M within a Senate supplemental; Dykema will continue to advocate for GLWA to secure this funding is approved by the House.

Michigan Saves is one of the largest nonprofit green banks in the country and helps support the governor’s MI Healthy Climate plan goal of achieving carbon neutrality by 2050. Dykema’s primary objective for Michigan Saves is achieving general fund appropriations. Dykema has been successful in achieving \$2.5 general fund appropriations over the past two budget cycles. ## C. Proposed Work Plan

Dykema's mission, firmly embedded in our culture, is to achieve true partnerships and cooperation among all of our professionals, staff, and clients. Our vision is perhaps best illustrated by our multifaceted client-service initiative involving every person in the firm. We strive to be the best service and value choice for clients. We have adopted a defined Dykema Client Service Standards, which represent our pledge not only to meet, but to exceed, client expectations.

In order to accomplish our mission, Dykema's overall philosophy to our government policy practice is a team approach. If selected, Dykema will work with Ann Arbor to designate account managers from our seven person government policy team. The designated account managers will be the main point of contact for the city and will be responsible for managing timelines and communications with Ann Arbor's leadership team. Under the direction of the account managers, Ann Arbor's objectives and advocacy in Lansing and Washington, DC will be propelled by all members of Dykema's government policy team. This team approach provides our clients the best opportunity for success. We recognize that each government policy advisor has different strengths and unique relationships in Lansing and Washington, DC. Dykema's government policy advisors will make it a priority to invest our time and resources towards understanding the City of Ann Arbor's operations, including your structure, strengths, and challenges.

Under the direction of the City Manager, we will work to implement specific strategies to help Ann Arbor impact changes in state and federal government policy, appropriations, and law by directly lobbying public officials regarding legislation and regulation. Our government policy advisors are strategic thinkers with demonstrated skills in implementing aggressive and proactive approaches to gain desired results. On behalf of Ann Arbor, we will craft effective messages, build coalitions, and work among stakeholder groups to achieve policy outcomes.

In order to proactively represent the City of Ann Arbor, we propose to do an immediate government relations planning session that will create an open dialogue and access to city leadership. This plan

will identify how and when city leadership will participate in virtual and in-person meetings in Lansing and Washington, DC to build rapport with elected officials and legislative and administration staff. The government relations plan will form the process to identify the appropriate city leadership team members that will need to participate and provide testimony in legislative hearings that have an impact on key city priorities. In order to successfully advocate for or against the passage of bills, rules, and/or regulations which impact Ann Arbor's interests, the arguments we present must be data-driven. We will work diligently with the city to gather and analyze data in order to make the most compelling case for policies and appropriations effecting Ann Arbor.

As part of Dykema's advocacy efforts for Ann Arbor, and in preparation for all such meetings, Dykema will work with Ann Arbor to develop a list of agenda items, related background information/status updates on agenda items, talking points to communicate the city's message regarding individual agenda items, and identify key legislators and staff with which to discuss the topics. Similarly, Dykema will help draft testimony and work with the city's leadership team to prepare as witnesses before legislative hearings. Our government policy advisors will ensure Ann Arbor team members attending meetings or appearing as witnesses understand the political context in which they are participating. During meetings, our government policy advisors will facilitate the discussion and work to keep conversations focused. All talks with state legislators, staff, and state department employees will be followed by a debrief with our team to analyze the discussion and next steps.

Dykema believes in partnering with our clients to develop a customized approach to achieve their specific public policy and appropriation goals. When we say "partner" with our clients, we mean it. We know that in order to develop the right government relations plans for the city, we must first engage and listen to you. Our priority will be to fully understand the city's specific objectives and goals so that we can design a custom government relations plan to achieve those goals and a means by which to measure our progress toward them.

Our approach in developing initiatives in order to shape policy and appropriations will involve a number of steps, starting with an inventory resource review – an extensive assessment that provides us with an understanding of the city's activities, programs, needs, and objectives. This includes an assessment of the city's current funding and policy priorities, identification of new opportunities for Ann Arbor to pursue, and development of an annual strategic plan for Ann Arbor's government affairs efforts with both immediate objectives and long-term goals.

Following the above mentioned review, and based upon our discussions with Ann Arbor leadership and our analysis of your resources, we will develop specific proposals to meet your needs and achieve the objectives identified.

Dykema's government policy advisors will provide the city manager and leadership team with an honest and timely assessment of any situation or issue related to the city's interests, politics, as well as policies. We will communicate with the city's leadership team on a regular basis to highlight any relevant legislative or political activity. At Ann Arbor's direction, our communications could include monthly written reports, bi-weekly or as often as needed telephone updates, regular email correspondence, and in-person updates at Ann Arbor's offices. We also recommend doing annual or bi-annual strategy sessions. The strategy sessions are a great opportunity to bring together the

CITY OF ANN ARBOR DECLARATION OF COMPLIANCE

Non-Discrimination Ordinance

The "non discrimination by city contractors" provision of the City of Ann Arbor Non-Discrimination Ordinance (Ann Arbor City Code Chapter 112, Section 9:158) requires all contractors proposing to do business with the City to treat employees in a manner which provides equal employment opportunity and does not discriminate against any of their employees, any City employee working with them, or any applicant for employment on the basis of actual or perceived age, arrest record, color, disability, educational association, familial status, family responsibilities, gender expression, gender identity, genetic information, height, HIV status, marital status, national origin, political beliefs, race, religion, sex, sexual orientation, source of income, veteran status, victim of domestic violence or stalking, or weight. It also requires that the contractors include a similar provision in all subcontracts that they execute for City work or programs.

In addition the City Non-Discrimination Ordinance requires that all contractors proposing to do business with the City of Ann Arbor must satisfy the contract compliance administrative policy adopted by the City Administrator. A copy of that policy may be obtained from the Purchasing Manager

The Contractor agrees:

- (a) To comply with the terms of the City of Ann Arbor's Non-Discrimination Ordinance and contract compliance administrative policy.
- (b) To post the City of Ann Arbor's Non-Discrimination Ordinance Notice in every work place or other location in which employees or other persons are contracted to provide services under a contract with the City.
- (c) To provide documentation within the specified time frame in connection with any workforce verification, compliance review or complaint investigation.
- (d) To permit access to employees and work sites to City representatives for the purposes of monitoring compliance, or investigating complaints of non-compliance.

The undersigned states that he/she has the requisite authority to act on behalf of his/her employer in these matters and has offered to provide the services in accordance with the terms of the Ann Arbor Non-Discrimination Ordinance. The undersigned certifies that he/she has read and is familiar with the terms of the Non-Discrimination Ordinance, obligates the Contractor to those terms and acknowledges that if his/her employer is found to be in violation of Ordinance it may be subject to civil penalties and termination of the awarded contract.

LIVING WAGE ORDINANCE DECLARATION OF COMPLIANCE

The Ann Arbor Living Wage Ordinance (Section 1:811-1:821 of Chapter 23 of Title I of the Code) requires that an employer who is (a) a contractor providing services to or for the City for a value greater than \$10,000 for any twelve-month contract term, or (b) a recipient of federal, state, or local grant funding administered by the City for a value greater than \$10,000, or (c) a recipient of financial assistance awarded by the City for a value greater than \$10,000, shall pay its employees a prescribed minimum level of compensation (i.e., Living Wage) for the time those employees perform work on the contract or in connection with the grant or financial assistance. The Living Wage must be paid to these employees for the length of the contract/program.

Companies employing fewer than 5 persons and non-profits employing fewer than 10 persons are exempt from compliance with the Living Wage Ordinance. If this exemption applies to your company/non-profit agency please check here  No. of employees \_\_\_

The Contractor or Grantee agrees:

- (a) To pay each of its employees whose wage level is not required to comply with federal, state or local prevailing wage law, for work covered or funded by a contract with or grant from the City, no less than the Living Wage. The current Living Wage is defined as \$14.05/hour for those employers that provide employee health care (as defined in the Ordinance at Section 1:815 Sec. 1 (a)), or no less than \$15.66/hour for those employers that do not provide health care. The Contractor or Grantor understands that the Living Wage is adjusted and established annually on April 30 in accordance with the Ordinance and covered employers shall be required to pay the adjusted amount thereafter to be in compliance with Section 1:815(3).

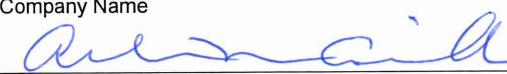

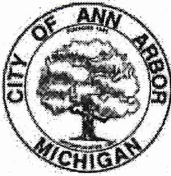

- (b) To post a notice approved by the City regarding the applicability of the Living Wage Ordinance in every work place or other location in which employees or other persons contracting for employment are working.
- (c) To provide to the City payroll records or other documentation within ten (10) business days from the receipt of a request by the City.
- (d) To permit access to work sites to City representatives for the purposes of monitoring compliance and investigating complaints or non-compliance.
- (e) To take no action that would reduce the compensation, wages, fringe benefits, or leave available to any employee covered by the Living Wage Ordinance or any person contracted for employment and covered by the Living Wage Ordinance in order to pay the living wage required by the Living Wage Ordinance.

The undersigned states that he/she has the requisite authority to act on behalf of his/her employer in these matters and has offered to provide the services or agrees to accept financial assistance in accordance with the terms of the Living Wage Ordinance. The undersigned certifies that he/she has read and is familiar with the terms of the Living Wage Ordinance, obligates the Employer/Grantee to those terms and acknowledges that if his/her employer is found to be in violation of Ordinance it may be subject to civil penalties and termination of the awarded contract or grant of financial assistance.
