# **Trunkline Transfer Study**

There have been long-standing community discussions about how state-owned trunklines which bisect the City serve the transportation needs of the community – namely, Washtenaw/Huron/Jackson and North Main. The City has limited ability to

make changes to these important roadways to align with the community's values since they are under state control. Consequently, City Council authorized a trunkline transfer study which would perform a cost-benefit analysis to look at the tradeoffs if the City were to take over ownership of these roadways. The final draft of this study is now complete and will be presented to the Transportation by staff and the consultant team that prepared the analysis. In addition to the materials included in the packet, some resources which provide background on the issue include:

- "City Ownership of State Trunklines Analysis" memo (1/3/22) from the City Administrator to City Council which outlined the proposed approach.
- "Resolution to Approve a Professional Services Agreement with Sam Schwartz

  proceed

# 2024 Resurfacing and Related Projects Update

The 2024 Street Resurfacing Program and Related Projects will be presented by staff. This annual presentation will highlight which areas of the City and roadways/paths are slated for rehabilitation or preservation work in the upcoming construction cycle. Additionally, the <a href="street/utility construction dashboard">street/utility construction dashboard</a> has been updated to show 2024 projects.

# All Ages and Abilities Bike Network and Miller Ave

A <u>capital project on Miller Ave</u> (Chapin St to Newport Rd) to make water main and storm sewer improvements is programmed for construction in 2024 and 2025. This project affords the City an opportunity to also consider incorporation of speed management and an All Ages and Abilities bike facility as called out for in the <u>Moving Together Towards Vision Zero Transportation Plan</u>. There is also interest in connecting such an All Ages and Abilities facility to existing bike facilities – namely to the Catherine cycle track (to the east) which ends at First; and to the Maple bike lanes (to the west). Staff will give a presentation on the current thinking of how to incorporate an all ages and abilities and answer any questions. This is in advance of public engagement on these concepts which we are targeting to occur sometime in March.
