This Indenture Made this Seventh day of December in the year one thousand eight hundred and ninety three, between Susan A. Orcutt, George Bailey, Mary J. Long and Elizabeth Coats and Channay G. Orcutt of the City of Ann Arbor of the one part and the City of Ann Arbor of the other part.

Witnesseth, That the said first party, in consideration of the agreements herein contained and the sum of one dollar to him in hand paid, the receipt whereof is hereby confessed done by these presents grant and convey to and unto said second party its successors and assigns, forever, the right, privilege, power and authority to enter on, into and upon all the following piece or parcels of land, to wit:

Block number one north of Huron Street range one east of the Village now City of Ann Arbor according to the recorded plat thereof, and therein and thereon, on, along and over such course as said second party shall or may elect, to construct and maintain a main sewer to its sewer system, making thereon all needful excavations therefor, and at all times thereafter to have the right and authority to enter in, upon and into said land aforesaid and the said main sewer, to keep and maintain in good order, and repair, rebuilding and reconstructing the same if necessary, using in said constructing or repairs all needful tools, implements, teams and material therefor.
