L. Stambaugh reported that the Fair Chance Access to Housing poster is ready and currently available on the HRC webpage and the City's Tenants' Resources webpage. The online complaint form to report violations of the Fair Chance Access to Housing Ordinance will be available soon.

Anti-Asian Hate Town Hall Meeting Plans

L. Stambaugh gave an update on the Anti-Asian Town Hall working group. Plans are in the process of being finalized. A. Ghazi, chair of Michigan Asian Pacific American Affairs Commission (MAPAAC), reported that prominent Asian American community leaders noted that the HRC can be a resource for their community.

CREW Study Group

P. Dent reported on the presentation given by Washtenaw County Prosecutor Eli Savit to the CREW Study Group about his office's reforms and initiatives.

Scheduling Strategic Planning

L. Stambaugh asked commissioners to notify her with their vacation dates to enable her to schedule a strategic planning meeting when all are available.

Crown Amendment update and addition requested

CM T. Radina reported on Council's approval of the addition of Creating a Respectful and Open World for Natural Hair (CROWN) language to the Non-Discrimination Ordinance (NDO). He also raised the question asked by constituents about whether the NDO should also protect against discrimination on the basis of religious head coverings. L. Winkler, D. Cass and A. Ghazi agreed to work on this.

Draft Resolution in Support of City Council

L. Stambaugh discussed the wording and title of the proposed resolution and unanimously voted to approve an amended resolution entitled: Resolution Condemning Offensive and/or Hateful Speech.

Approved as amended by the Board and forwarded to the City Council due back on 9/20/2021

NEW BUSINESS

Social Work Class Project II

In response to a request by A. Ghazi, commissioners agreed to again invite students in her UM School of Social Work policy course to research and present their findings on topics of interest to the HRC.

COMMUNICATIONS

HRC will meet in July and August via Zoom.

The City Council has passed; Juneteenth an official holiday in Ann Arbor. City offices will be closed. The Ann Arbor NAACP is hosting a celebration event on Saturday, June 19th beginning with a march from Fuller Park to Wheeler Park at 9:00am.

D. Das suggested that climate emergency and environmental justice are Human Rights issues that should be on the HRC's radar.
