Additionally, Ms. Goode neglected to attend our meeting with Zacharia ... due to illness, if she had been able to attend perhaps a request for a second meeting wouldn't be necessary. Since Zacharia left we feel our message wasn't received.

My team and I will be compiling, in writing, our observations on how this ordinance has impacted the market and the students, but it will take some time to put together a comprehensive report.

After watching the meeting, I couldn't help but question how involved the Renters Commission actually is in drafting leasing ordinances. Am I wasting my time—and theirs—by relaying our findings based on these leasing ordinances? From what I observed, the commission seems completely uninvolved in the drafting process and may not even get a chance to review the changes before they're presented to the city council. Would we be better off reaching out to those more involved, such as Travis Radina and John Reiser? Is there someone else you would recommend we speak to who is working on the changes to the ordinance?
