Dear Council Members and Mayor Taylor -

I am writing to express my support for moving forward with the Care-Based Safety proposal for unarmed response. First, I want to thank you for your support of unarmed response in our community.

The Care-Based Safety proposal was designed for the community, by the community. It is well researched, designed specifically with the Ann Arbor community in mind, and drafted by and for Ann Arborites that will directly benefit from such a program. Further, it is built upon something that is unburdened by outdated paradigms and carceral systems.

I understand that the RFP was canceled. In the case that you've not had the opportunity to read over the full proposal, I ask that you take the time to do so here and to re-read the RFP that the proposal is responding to, as there are no discrepancies.

For these reasons, I am requesting the following -

1) Transparency: I am asking Council to release the minutes and all written materials from the 12/18 meeting and to directly engage and discuss Care-Based Safety's proposal with them and with the public

2) Approval/negotiation of the contract: I am encouraging the City Council to re-open the RFP and to direct staff to approve the contract with Care-Based Safety and to negotiate a contract with them so we can operationalize these resources as soon as possible

3) Swiftness: I am requesting that Council treat this with immediate urgency. The ARPA funds are time bound and more than that, people in our community desperately need these resources now.

Dear Ann Arbor City Council,

The resolution proposed for consideration this evening which calls for a cease-fire in Gaza is tailor-made to assist Hamas. This resolution ignores the obvious fact that there was no fighting, there was a cease-fire, on October 6 before Hamas launched their barbaric attack on Israeli civilians, killing over 1250. If Hamas wants a cease-fire, it should release its civilian hostages and forswear further constant pledges to destroy Israel.

Like any country, Israel is entitled to defend itself against brazen attack by enemies pledged to destroy it. To implement a cease-fire now -- which is Hamas' highest objective -- would be to preserve Hamas military power and thereby guarantee future attacks on Israel and future civilian suffering on both sides. Why would you condemn the party trying to defend itself, and sanctify the aggressor? Bear mind as well that Israel has offered to recognize a Palestinian state and end the entire conflict on at least four occasions -- but all peace offers have been rejected by Palestinian leadership committed is just destruction.
