Resolution to Approve the Request from The Songbird Café for a Resort Class C Liquor License to be Located at 2707 Plymouth Rd., Ann Arbor - D/B/A The Songbird Cafe

**Sponsors:** Council Liquor License Review Committee

*Jenny Song of The Songbird Cafe was present to answer questions of staff and the committee.*

*Lt. Bush of the Ann Arbor Police Department expressed concerns about the applicant's qualifications as a Resort as defined by the MLCC. She stated the seating capacity, lack of entertainment, or definition as a "destination location", and limited food menu, at this time did not appear to qualify for a Resort License.*

*Ms. Song responded that currently she provides occasional entertainment options, such as a guitar player. She noted that she is near North Campus hotels and she makes her space available for meetings. She stated The Songbird Cafe can be an "anchor" to the northside area.*

*Committee members raised additional questions and concerns regarding the current lack of seating capacity as required by the Resort designation. Currently, Ms. Song only provides for 85 seats.*

*The City Clerk provided a list of other establishments in the City who have received Resort classified licenses, as was requested by the Committee at their last meeting.*

**A motion was made by Kailasapathy, seconded by Lumm, that the Resolution be Recommended for Adoption by the City Council. On a roll call, the vote was as follows with the chair declaring the motion defeated:**

2015 Annual Renewal Process
