**SUBJECT: 3875 E. Huron River Drive Rezoning
Project No. Z13-011**

PROPOSED CITY PLANNING COMMISSION MOTION

The Ann Arbor City Planning Commission hereby recommends that the Mayor and City Council approve the 3875 E. Huron River Drive from R1A (Single-Family Dwelling District) to PL (Public Land District) Zoning.

STAFF RECOMMENDATION

Staff recommends this petition be **approved** because the property is now owned by the City of Ann Arbor and will contain a public use.

LOCATION

This site is located on the north side of E. Huron River Drive, west of Thorn Oaks Drive. This site is in the Huron River Watershed.

DESCRIPTION OF PETITION

The petitioner requests rezoning from R1A (Single-Family Dwelling District) to PL (Public Land District) zoning to accommodate park and open space uses. The two-acre site includes a single-family home and circular driveway.

HISTORY AND PLANNING BACKGROUND

The property was acquired as parkland by the City of Ann Arbor in 2008. The life estate ended in 2013. The site is served by sanitary sewer and storm sewer.

STAFF COMMENTS

Planning – The PL (Public Land) zoning is appropriate for this City owned parcel. PL zoning allows public uses as described in Chapter 55 (Zoning) Section 5:10.13 such as outdoor public recreation, natural open space, developed open space, educational services, cultural services, and essential services. The Parks & Recreation Services Unit currently is considering future uses for the site including possible uses by the Natural Area Preservation staff. The Master Plan: Land Use Element recommends Parks and Recreation uses for the site.

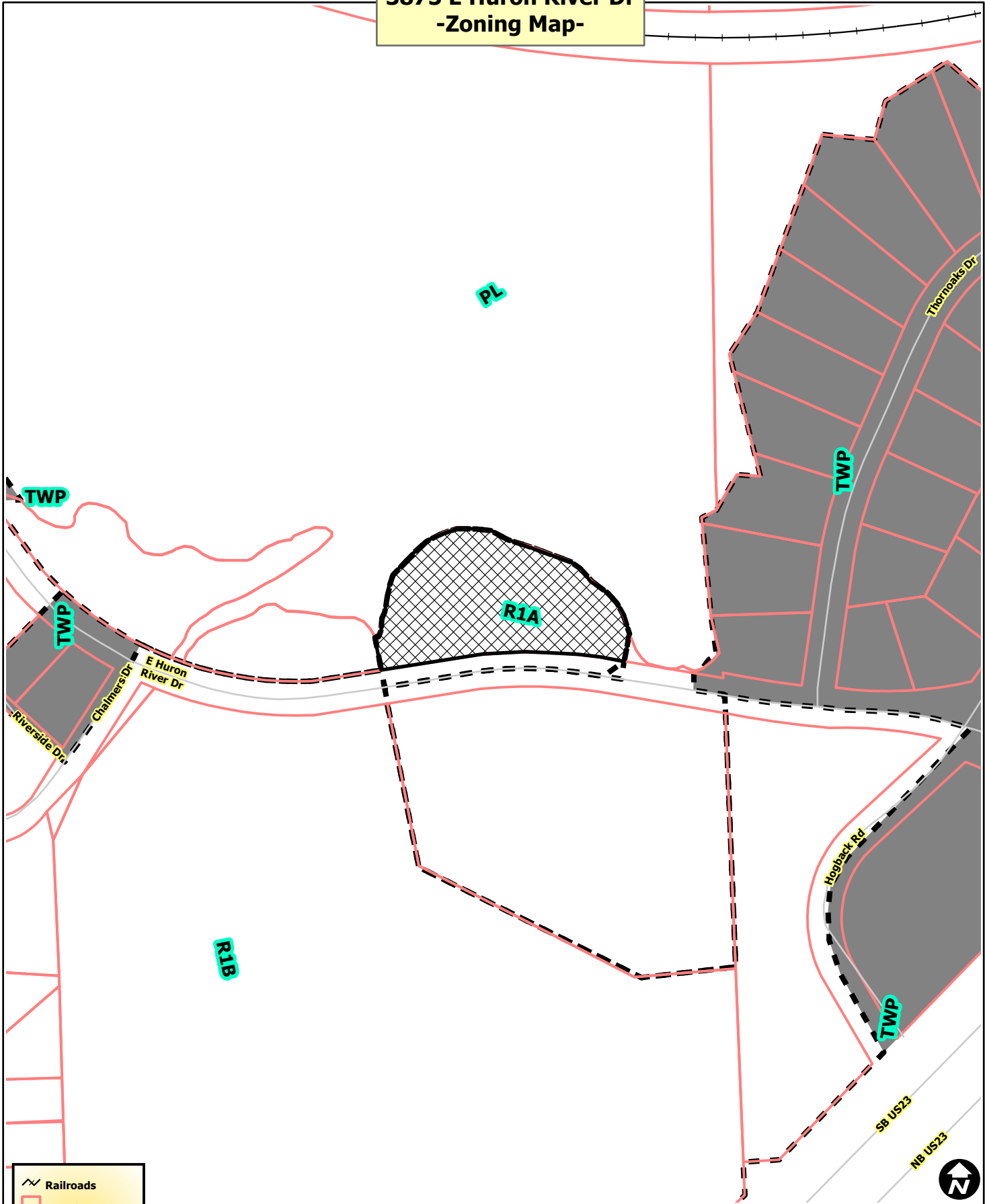
