*Jeff Crockett. 506 East Kingsley, stated increased density may contribute to higher land values, development and infrastructure costs, rents, and auto insurance rates.*

*Adam Jaskewicz, Las Vegas Drive, expressed support for minimum height requirements and for the draft plan overall.*

*John Godfrey, 2809 Brockman Avenue, stated that he does not support the plan because he believes it will not improve housing affordability and may attract profiteering.*

*Chuck Ream, Packard Street, expressed concern that reduced setbacks could affect modern tree protections.*

*Resident, stated that the plan does not sufficiently address ADA requirements for new housing.*

*Tom Stulberg, 1202 Traver Street, stated that the summary of public comments is inadequate.*

*Irma Majer, Brockman Boulevard, stated that public engagement efforts were inadequate.*

*Ken Garber, 28 Haverhill Court, stated his submitted comments have not been addressed and noted current systems are not sustainable.*

*Joe Zilka, 1920 Woodbury Drive, stated that housing development has not kept pace with population growth and expressed support for housing along transit corridors.*

*Tricia Hackney, The Crossing Condominiums, expressed concern about changes proposed for neighborhoods.*

*Jirka Hladis, Ward 1, expressed support for the draft Comprehensive Plan and suggested reconsidering the term "residential".*

*Brad Pritts stated the plan should be paused noting he believes it does not comply with state law and that engagement was inadequate.*

*Sarah Bassiouni, Ward 5, expressed support for the draft but wished it took a more expansive approach to welcoming new residents.*

*James D'Amour stated that the Natural Features Plan should be included and emphasized balancing growth with protection of natural systems.*

*Ross Smith expressed support for the Comprehensive Plan but wished it were more ambitious.*

*Planning Manager Brett Lenart reported at the Wednesday, January 21, 2026 City Planning Commission:*

*Woodbury Gardens Rezoning (REZ24-0008) and 1310 Wisteria Site Plan (SP24-0013) for City Council approval: Woodbury Gardens proposes to rezone the existing 41.292 acre development that includes Astor Drive, Wisteria Drive, and Woodbury Drive from R3 (Multiple Family), R4 (multiple family), and PL (Public Land) districts to TC1 (transit corridor), with conditions capping the building height. The site plan project would partially redevelop one parcel to construct two seven-story buildings containing 342 dwelling units, and a five level parking garage. An administrative land transfer is required and will be considered separately.*

*495 Earhart Road, St Paul Lutheran School site plan for City Planning Commission approval. A proposal to add a 2,582 square foot building addition for a library, reconstruct and reconfigure the parking lot, and upgrade the stormwater detention. No increase in the number of students is expected as a result of this work. Zoned R1B (Single Family).*
