*WTP Stairwell Project Update - Seven artists submitted proposals before the 10/31/21 deadline and four short-listed artists were chosen in December. Second stage renderings from the four short-listed artists were due before 2/15/22. There is a meeting scheduled for 3/10 to discuss the second stage renderings that were submitted, and a final decision will be made on an artist at that meeting. Final completion of the painted mural date is no later than November 2022.*

*City Flag Re-design – Mayor to make this request to City Council. Staff has provided the resolution directing the commission to undertake this project; it is up to Mayor Taylor to put the resolution before City council.*

*Upcoming Commission Appointments - March 1st deadline is very close. We have heard from one commissioner, who will end his appointment at the end of this term due to current commitments. One member wishes to seek reappointment and not response from the third commissioner. Please let me know as soon as possible about your decision*
