

**Amendment No. 1 to Agreement Between  
The City of Ann Arbor on behalf of the 15<sup>th</sup> Judicial District Court  
and  
The Washtenaw County Sheriff's Office**

The City of Ann Arbor (the "City"), a municipal corporation, on behalf of the 15<sup>th</sup> Judicial District Court (the "Court") located at 301 E. Huron Street, Ann Arbor, MI 48104 and the Washtenaw County Sheriff's Office, located at 2201 Hogback, Ann Arbor, MI 48105 (the "Contractor"), agree to amend the agreement to provide drug abuse screening services to participants of the 15th Judicial District Court Veterans Treatment Court and Sobriety Court executed by the parties dated February 12, 2015 as follows:

- 1) Article V – Compensation is amended to read as follows:

ARTICLE V - COMPENSATION

Upon completion of the above services and submission of detailed invoices for each Court as specified in Article IV above, the City on behalf of the Court will pay the Contractor an amount not to exceed One Hundred Nineteen Thousand Two Hundred Twenty Three Dollars and Twenty Cents (\$119,223.20) (Veterans Treatment Court NTE \$36,993.20, Mental Health Court NTE \$79,700.00 and Sobriety Court NTE \$2,580.00) for all services rendered under this contract for Grant Fiscal Year 2015 subject to the restrictions stated in Article V below.

These services are funded through grants from the Supreme Court of Michigan State Court Administrative Office Veterans Treatment Court Grant Program (SCAO-MVTCGP) (\$36,993.20), the Michigan Mental Health Court Grant Program (SCAO-MMHCGP) (\$79,700.00) and the Michigan Drug Court Grant Program (SCAO-MDCGP) (\$2,580.00) for Grant Fiscal Year 2015.

The parties agree that the City on behalf of the Court will compensate the Contractor only to the extent that SCAO-MVTCGP, SCAO-MMHCGP and SCAO- MDCGP funds are actually awarded to and received by the Court.

All terms, conditions, and provisions of the original agreement between the parties executed February 12, 2015, unless specifically amended above, are to apply to this amendment and are made a part of this amendment as though expressly rewritten, incorporated, and included herein.

This amendment to the agreement between the parties shall be binding on the heirs/successors and assigns of the parties.
