"Neighborhood context"

Do a search on this phrase and either eliminate or replace with "political considerations" or more authentic phrasing. Using "context" strengthens complaints about most additions of housing.

"support sustainability by preserving embodied carbon in existing buildings"

Omit, counterproductive policy

"Support and preserve existing subsidized income-eligible housing and non-subsidized housing and make it more sustainable"

Strike "and preserve" as it is not relevant to existing subsidized housing and counterproductive policy for non-subsidized housing.

"As more investment occurs in the city, vulnerable residents must be protected to ensure they are not displaced."

Omit. This is incorrect and has already led to bad policy decisions to attempt to preserve "naturally occurring affordable housing." Investment may displace residents on the parcel level but — assuming zoning requires redevelopment to be more dense that what it replaces — research indicates that investment in fact reduces displacement in the regional housing market.

"maintain current subsidized and unsubsidized affordable housing"

Strike "and unsubsidized" or the entire paragraph.

Omit first 3 bullets justifying preserving industrial zones.

"Arborland and Briarwood are among the city's major taxpayers."

Omit; can lead to bad policy. This is not on a per-acre basis.

79

"For example, advancing the city's A2ZERO circular economy goals may require industrial-scale facilities for activities such as recycling and repair, returnable container washing, or storage for thrift stores. Hybrid businesses, responding to a changing retail landscape, may sell consumer products while also requiring space for distribution or simple manufacturing... flexibility for hybrid businesses and industrial facilities should remain a priority."
