After discussion of each of the four options, the committee decided on Option C: a tree planted in the triangle plant area with the stone moved back to the triangle. Additionally, the committee requests that the interpretive sign mentioned in option D be included in the space where the stone currently sits with two trees planted adjacent or behind the new sign.

Trees should all be large canopy shade trees native to Michigan and that do not shed in consideration of the folks that use the walking path. Committee leaves the decision of species to staff, but recommend elm in some capacity.
