1 Legislative update

**Deputy City Administrator John Fournier and Ms. Cascarilla provided a legislative update about legislative activity at the state and federal levels. The Governor will be speaking on Wednesday, August 30 about her fall priorities.**

2 Funding request strategy

**Deputy City Administrator Fournier remarked that the results of the federal earmark requests had not been successful and staff is working with Dykema Gossett to coordinate a improved strategy for future funding requests.**

3 Legislative event

**Mr. Fournier informed the group that staff is working to coordinate a legislative breakfast event. The event will be coordinated around the schedules of elected officials. Details will be forthcoming.**

4 Driving Equity Ordinance

**Councilmember Harrison introduced and explained the Driving Equity Ordinance recently passed by City Council to Ms. Cascarilla. She reiterated the importance of this work and asked Ms. Cascarilla to assist with advancing efforts for a similar statewide policy or regulation. The group agreed with this effort.**

5 Non-motorized safe crossings on the Amtrak Michigan Line

**Mr. Fournier indicated that the Michigan Department of Transportation had recently heard public comment about the safety of non-motorized crossings on the Amtrak Michigan Line. The City will prepare a letter to MDOT formally stating its opinion about the necessity of safe crossings.**
