OF INTENT TO ISSUE GENERAL OBLIGATION CAPITAL IMPROVEMENT BONDS SECURED BY THE TAXING POWER OF THE CITY TO FUND THE REPLACEMENT OF FIRE STATION NO. 4 AND OF THE RIGHT TO PETITION FOR REFERENDUM THEREON

PLEASE TAKE NOTICE that the City Council of the City of Ann Arbor, Washlenaw County, Michigan (the "City"), intends to authorize the issuance and sale of the City's Limited Tax General Obligation Capital Improvement Bonds, pursuant to Act 34, Public Acts of Michigan, 2001, as amended, in one or more series, in an aggregate principal amount of not to exceed Twelve Million Dollars (\$12,000,000) (the "Bonds") for the purpose of paying all or part of the costs to acquire, construct, furnish and equip a new fire station to replace Fire Station No. 4, Including turniture, fixtures, furnishings, equipment, utilities, site improvements, and public improvements in the surrounding area, together with appurtenances and attachments thereto, and demofition of the existing Station No. 4 (the "Project").

SAID BONDS will be payable in annual Installments, not to exceed twenty (20) in number, and will bear interest at the rate or rates to be determined at a public or negotiated sale, but in no event to exceed the maximum rate permitted by law, on the unpaid batance from time to time remaining on said Bonds.

SOURCE OF PAYMENT OF BONDS

THE PRINCIPAL OF AND INTEREST ON SAID BONDS shall be payable from the general funds of the City lawfully available for such purposes including property taxes levled within applicable constitutional, statutory and charter tax rate limitations. The City anticipates paying all or part of debt service on the Bonds from payments received from the State of Michigan for providing fire protection service to certain state-owned facilities.

RIGHT TO PETITION FOR REFERENDUM

The Bonds will be Issued without a vote of the electors unless a valid pelition requesting such a vote signed by not less than 10% or 15,000 of the registered electors of the City is tiled with the City Clerk within forty-five (45) days after publication of this notice. If a valid petition is filled, the Bonds may not be issued without an approving vote of the majority of the qualified electors of the City voting thereon.

This notice is given by order of the City Council pursuant to the requirements of Section 517, Act 34, Public Acts of Michigan, 2001, as amended.
