

**ELEVENTH AMENDED AND RESTATED
GENERAL SERVICES AGREEMENT BETWEEN
RECYCLE ANN ARBOR AND THE CITY OF ANN ARBOR FOR
MULTI-FAMILY AND COMMERCIAL RECYCLING COLLECTION SERVICES**

This Amendment Number 11 and Restatement of the General Services Agreement ("Amendment") is to the agreement between the City of Ann Arbor, a Michigan municipal corporation, with offices at 301 East Huron Street, Ann Arbor, Michigan 48107 ("City") and Recycle Ann Arbor, a Michigan nonprofit corporation, with its address at P.O. Box 7180, Ann Arbor, Michigan 48107, ("Contractor") for Municipal Recovery Services for the City of Ann Arbor, which is dated December 1, 2003, amended by Amendment #1 effective March 2, 2005, amended by Amendment #2 effective May 13, 2010, amended by Amendment #3 effective August 29, 2011, amended by Amendment #4 effective August 18, 2015, amended by Amendment #5 effective June 29, 2018 amended by Amendment #6 effective June 3, 2019, amended by Amendment #7 effective July 28, 2020, amended by Amendment #8 effective June 30, 2021, amended by Amendment #9 effective January 1, 2023, and amended by Amendment #10 effective March 1, 2023 ("Agreement"). City and Contractor hereby agree to amend and restate the General Services Agreement as follows:

1. DEFINITIONS

Administering Service Area/Unit means **Public Services / Public Works – Solid Waste**.

Contract Administrator means the Solid Waste Manager, acting personally or through any assistants authorized by the Administrator/Manager of the Administering Service Area/Unit.

Deliverables means all services, documents, plans, specifications, reports, recommendations, and other materials developed for and delivered to City by Contractor under this Agreement.

Effective Date means the date this Agreement is signed by the last party to sign it.

Services means Multi-Family and Commercial Recycling Collection Services as further described in Exhibit A.

2. DURATION

The obligations of this Agreement shall apply beginning on July 01, 2026 and this Agreement shall remain in effect through June 30, 2028 unless terminated as provided for in this Agreement.

3. SERVICES

- A. Contractor shall perform all Services in compliance with this Agreement. The City retains the right to make changes to the quantities of Services within the general scope of the Agreement at any time subject to the terms of this Agreement. If the changes add to or deduct from the extent of the Services, the compensation shall be adjusted accordingly. All such changes shall be executed under the conditions of the original Agreement.
- B. Quality of Services under this Agreement shall be of the level of quality performed by persons regularly rendering this type of service. Determination of acceptable quality shall be made solely by the Contract Administrator.
- C. Contractor shall perform Services in compliance with all applicable statutory, regulatory, and contractual requirements now or hereafter in effect. Contractor shall also comply with and be subject to City policies applicable to independent contractors.
- D. Contractor may rely upon the accuracy of reports and surveys provided by the City, except when a defect should have been apparent to a reasonably competent professional or when Contractor has actual notice of a defect.

4. INDEPENDENT CONTRACTOR

- A. The parties agree that at all times and for all purposes under the terms of this Agreement each party's relationship to any other party shall be that of an independent contractor. Each party is solely responsible for the acts of its own employees, agents, and servants. No liability, right, or benefit arising out of any employer-employee relationship, either express or implied, shall arise or accrue to any party as a result of this Agreement.
- B. Contractor does not have any authority to execute any contract or agreement on behalf of the City, and is not granted any authority to assume or create any obligation or liability on the City's behalf, or to bind the City in any way.

5. COMPENSATION OF CONTRACTOR

- A. The total amount of compensation paid to Contractor under this Agreement shall not exceed \$2,912,051.40 which shall be paid upon invoice by Contractor to the City for services rendered according to the schedule in Exhibit B.
- B. Payment shall be made monthly following receipt of invoices submitted by Contractor and approved by the Contract Administrator, unless a different payment schedule is specified in Exhibit B.
- C. Contractor shall be compensated for additional work or Services beyond those specified in this Agreement only when the scope of and compensation for the additional work or Services have received prior written approval of the Contract Administrator.
- D. Contractor shall keep complete records of work performed (e.g. tasks performed, hours allocated, etc.) so that the City may verify invoices submitted by Contractor.

Such records shall be made available to the City upon request and submitted in summary form with each invoice.

6. INSURANCE/INDEMNIFICATION

- A. Contractor shall procure and maintain from the Effective Date of this Agreement through the conclusion of this Agreement, such insurance policies, including those required by this Agreement, as will protect itself and the City from all claims for bodily injury, death, or property damage that may arise under this Agreement; whether the act(s) or omission(s) giving rise to the claim were made by Contractor, Contractor's subcontractor, or anyone employed by Contractor or Contractor's subcontractor directly or indirectly. Prior to commencement of work under this Agreement, Contractor shall provide documentation to the City demonstrating Contractor has obtained the policies and endorsements required by this Agreement. Contractor shall provide such documentation in a form and manner satisfactory to the City. Currently, the City requires insurance to be submitted through its contractor, myCOI. Contractor shall add registration@mycoitracking.com to its safe sender's list so that it will receive necessary communication from myCOI. When requested, Contractor shall provide the same documentation for its subcontractors.
- B. All insurance providers of Contractor shall be authorized to do business in the State of Michigan and shall carry and maintain a minimum rating assigned by A.M. Best & Company's Key Rating Guide of "A-" Overall and a minimum Financial Size Category of "V". Insurance policies and certificates issued by non-authorized insurance companies are not acceptable unless approved in writing by the City.
- C. To the fullest extent permitted by law, Contractor shall indemnify, defend, and hold the City and its officers, employees, and agents harmless from all suits, claims, judgments, and expenses, including attorney's fees, resulting or alleged to result, from an act or omission by Contractor or Contractor's employees or agents occurring in the performance or breach of this Agreement, except to the extent that any suit, claim, judgment, or expense are finally judicially determined to have resulted from the City's negligence, willful misconduct, or failure to comply with a material obligation of this Agreement. The obligations of this paragraph shall survive the expiration or termination of this Agreement.
- D. Contractor is required to have the following minimum insurance coverage:
1. Commercial General Liability Insurance equivalent to, as a minimum, Insurance Services Office form CG 00 01 04 13 or current equivalent. The City of Ann Arbor shall be an additional insured. There shall be no added exclusions or limiting endorsements that diminish the City's protections as an additional insured under the policy.

 2. Worker's Compensation Insurance in accordance with all applicable state and federal statutes; also, Employers Liability Coverage for:

Bodily Injury by Accident - \$500,000 each accident
Bodily Injury by Disease - \$500,000 each employee
Bodily Injury by Disease - \$500,000 each policy limit

3. Motor Vehicle Liability Insurance equivalent to, as a minimum, Insurance Services Office form CA 00 01 10 13 or current equivalent. Coverage shall include all owned vehicles, all non-owned vehicles and all hired vehicles. The City of Ann Arbor shall be an additional insured. There shall be no added exclusions or limiting endorsements that diminish the City's protections as an additional insured under the policy. The limits of liability shall be \$1,000,000 for each occurrence as respects Bodily Injury Liability or Property Damage Liability, or both combined.
 4. Umbrella/Excess Liability Insurance shall be provided to apply in excess of the Commercial General Liability, Employers Liability and the Motor Vehicle coverage enumerated above, for each occurrence and for aggregate in the amount of \$1,000,000.
- E. Commercial General Liability Insurance and Motor Vehicle Liability Insurance (if required by this Agreement) shall be considered primary as respects any other valid or collectible insurance that the City may possess, including any self-insured retentions the City may have; and any other insurance the City does possess shall be considered excess insurance only and shall not be required to contribute with this insurance. Contractor agrees to waive any right of recovery by its insurer against the City for any insurance listed herein.
- F. Insurance companies and policy forms are subject to approval of the City Attorney, which approval shall not be unreasonably withheld. Documentation must provide and demonstrate an unconditional and unqualified 30-day written notice of cancellation in favor of the City of Ann Arbor. Further, the documentation must explicitly state the following: (a) the policy number(s); name of insurance company; name(s), email address(es), and address(es) of the agent or authorized representative; name and address of insured; project name; policy expiration date; and specific coverage amounts; (b) any deductibles or self-insured retentions, which may be approved by the City in its sole discretion; (c) that the policy conforms to the requirements specified. Contractor shall furnish the City with satisfactory certificates of insurance and endorsements prior to commencement of any work. If any of the above coverages expire by their terms during the term of this Agreement, Contractor shall deliver proof of renewal and/or new policies and endorsements to the Administering Service Area/Unit at least ten days prior to the expiration date.

7. **WAGE AND NONDISCRIMINATION REQUIREMENTS**

- A. Nondiscrimination. Contractor shall comply, and require its subcontractors to comply, with the nondiscrimination provisions of MCL 37.2209. Contractor shall comply with the provisions of Section 9:158 of Chapter 112 of Ann Arbor City Code and assure that Contractor's applicants for employment and employees are treated in a manner which provides equal employment opportunity.

- B. Living Wage. If Contractor is a “covered employer” as defined in Chapter 23 of Ann Arbor City Code, Contractor must comply with the living wage provisions of Chapter 23 of Ann Arbor City Code, which requires Contractor to pay those employees providing Services to the City under this Agreement a “living wage,” as defined in Section 1:815 of the Ann Arbor City Code, as adjusted in accordance with Section 1:815(3); to post a notice approved by the City of the applicability of Chapter 23 in every location in which regular or contract employees providing services under this Agreement are working; to maintain records of compliance; if requested by the City, to provide documentation to verify compliance; to take no action that would reduce the compensation, wages, fringe benefits, or leave available to any employee or person contracted for employment in order to pay the living wage required by Section 1:815; and otherwise to comply with the requirements of Chapter 23.
- C. Prevailing Wage. Contractor shall comply with Chapter 14 of Title I of Ann Arbor City Code, which in part states "...that all craftsmen, mechanics and laborers employed directly on the site in connection with said improvements, including said employees of subcontractors, shall receive the prevailing wage for the corresponding classes of craftsmen, mechanics and laborers, as determined by statistics for the Ann Arbor area compiled by the United States Department of Labor. At the request of the City, any contractor or subcontractor shall provide satisfactory proof of compliance with the contract provisions required by the Section." Where this Agreement and the Ann Arbor City Code are silent as to definitions of terms required in determining compliance with regard to prevailing wages, the definitions provided in the Davis-Bacon Act as amended (40 U.S.C. 278-a to 276-a-7) for the terms shall be used.
- D. Contractor agrees that all subcontracts entered into by Contractor shall contain wage provisions similar to section 7.B and 7.C of this Agreement covering subcontractor's employees who perform work under this Agreement.

8. REPRESENTATIONS AND WARRANTIES BY CONTRACTOR

- A. Contractor warrants that the quality of Services shall conform to the level of quality performed by persons regularly rendering this type of service.
- B. Contractor warrants that it has all the skills, experience, and professional and other licenses necessary to perform the Services.
- C. Contractor warrants that it has available, or will engage at its own expense, sufficient trained employees to provide the Services.
- D. Contractor warrants that it has no personal or financial interest in this Agreement other than the compensation it is to receive under this Agreement. Contractor certifies that it will not acquire any such interest, direct or indirect, which would conflict in any manner with the performance of the Services. Contractor certifies that it does not and will not employ or engage any person with a personal or financial interest in this Agreement.
- E. Contractor warrants that it is not, and shall not become overdue or in default to the City for any contract, debt, or any other obligation to the City, including real and personal property taxes. Further Contractor agrees that the City shall have the right to

set off any such debt against compensation awarded for Services under this Agreement.

- F. Contractor warrants that its bid or proposal for services under this Agreement was made in good faith, that it arrived at the costs of its proposal independently, without consultation, communication, or agreement for the purpose of restricting competition as to any matter relating to such costs with any competitor for these services; and no attempt has been made or will be made by Contractor to induce any other person or entity to submit or not to submit a bid or proposal for the purpose of restricting competition.
- G. The person signing this Agreement on behalf of Contractor represents and warrants that they have express authority to sign this Agreement for Contractor and agrees to hold the City harmless for any costs or consequences of the absence of actual authority to sign.
- H. The obligations, representations, and warranties of this section 8 shall survive the expiration or termination of this Agreement.

9. OBLIGATIONS OF THE CITY

- A. The City shall give Contractor access to City properties and project areas as required to perform the Services.
- B. The City shall notify Contractor of any defect in the Services of which the Contract Administrator has actual notice.

10. ASSIGNMENT

- A. Contractor shall not subcontract or assign any portion of any right or obligation under this Agreement without prior written consent from the City. Notwithstanding any consent by the City to any assignment, Contractor shall at all times remain bound to all warranties, certifications, indemnifications, promises, and performances required of Contractor under the Agreement unless specifically released from the requirement in writing by the City.
- B. Contractor shall retain the right to pledge payments due and payable under this Agreement to third parties.

11. TERMINATION OF AGREEMENT

- A. If either party is in breach of this Agreement for a period of 30 days following receipt of notice from the non-breaching party with respect to the breach, the non-breaching party may pursue any remedies available against the breaching party under applicable law, including the right to terminate this Agreement without further notice. The waiver of any breach by any party to this Agreement shall not waive any subsequent breach by any party.

- B. The City may terminate this Agreement, on at least 60 days' advance notice, for any reason, including convenience, without incurring any penalty, expense, or liability to Contractor, except the obligation to pay for Services actually performed under the Agreement before the termination date.
- C. Contractor acknowledges that if this Agreement extends for several fiscal years, continuation of this Agreement is subject to appropriation of funds through the City budget process. If funds are not appropriated or otherwise made available, the City shall have the right to terminate this Agreement without penalty at the end of the last period for which funds have been appropriated or otherwise made available by giving written notice of termination to Contractor. The Contract Administrator shall give Contractor written notice of such non-appropriation within 30 days' after the Contract Administrator has received notice of such non-appropriation.
- D. The expiration or termination of this Agreement shall not release either party from any obligation or liability to the other party that has accrued at the time of expiration or termination, including a payment obligation that has already accrued and Contractor's obligation to deliver all Deliverables due as of the date of termination of the Agreement.

12. REMEDIES

- A. This Agreement does not, and is not intended to, impair, divest, delegate, or contravene any constitutional, statutory, or other legal right, privilege, power, obligation, duty, or immunity of the parties.
- B. All rights and remedies provided in this Agreement are cumulative and not exclusive, and the exercise by either party of any right or remedy does not preclude the exercise of any other rights or remedies that may now or subsequently be available at law, in equity, by statute, in any other agreement between the parties, or otherwise.
- C. Absent a written waiver, no act, failure, or delay by a party to pursue or enforce any right or remedy under this Agreement shall constitute a waiver of that right with regard to any existing or subsequent breach of this Agreement. No waiver of any term, condition, or provision of this Agreement, whether by conduct or otherwise, shall be deemed or construed as a continuing waiver of any term, condition, or provision of this Agreement. No waiver by either party shall subsequently affect the waiving party's right to require strict performance of this Agreement.

13. NOTICE

All notices and submissions required under this Agreement shall be delivered to the respective party in the manner described herein to the address stated below or such other address as either party may designate by prior written notice to the other. Notices given under this Agreement shall be in writing and shall be personally delivered, sent by next day express delivery service, certified mail, or first class U.S. mail postage prepaid, and addressed to the person listed below. Notice will be deemed given on the date when one of the following first occur: (1) the date of actual receipt; (2) the next business day when notice is sent next day express delivery service or personal delivery; or (5) five days after mailing first class or certified U.S. mail.

14. CHOICE OF LAW AND FORUM

This Agreement will be governed and controlled in all respects by the laws of the State of Michigan, including interpretation, enforceability, validity and construction, excepting the principles of conflicts of law. The parties submit to the jurisdiction and venue of the Circuit Court for Washtenaw County, State of Michigan, or, if original jurisdiction can be established, the United States District Court for the Eastern District of Michigan, Southern Division, with respect to any action arising, directly or indirectly, out of this Agreement or the performance or breach of this Agreement. The parties stipulate that the venues referenced in this Agreement are convenient and waive any claim of non-convenience.

15. OWNERSHIP OF DOCUMENTS

Upon completion or termination of this Agreement, all Deliverables prepared by or obtained by Contractor as provided under the terms of this Agreement shall be delivered to and become the property of the City. Original basic survey notes, sketches, charts, drawings, partially completed drawings, computations, quantities, and other data shall remain in the possession of Contractor as instruments of service unless specifically incorporated in a Deliverable, but shall be made available, within sixty (60) days of request, to the City without restriction or limitation on their use. The City acknowledges that the documents are prepared only for the Services. Prior to completion of the Services the City shall have a recognized proprietary interest in the Deliverables.

16. CONFLICTS OF INTEREST OR REPRESENTATION

- A. Contractor certifies it has no financial interest in the Services to be provided under this Agreement other than the compensation specified herein. Contractor further certifies that it presently has no personal or financial interest, and shall not acquire any such interest, direct or indirect, which would conflict in any manner with its performance of the Services under this Agreement.
- B. Contractor agrees to advise the City if Contractor has been or is retained to handle any matter in which its representation is adverse to the City and to obtain the City's consent therefor. The City's prospective consent to Contractor's representation of a client in matters adverse to the City, as identified above, will not apply in any instance where, as the result of Contractor's representation, Contractor has obtained sensitive, proprietary, or otherwise confidential information of a non-public nature that, if known to another client of Contractor, could be used in any such other matter by the other client to the material disadvantage of the City. Each matter will be reviewed on a case by case basis.

17. SEVERABILITY OF PROVISIONS

Whenever possible, each provision of this Agreement will be interpreted in a manner as to be effective and valid under applicable law. However, if any provision of this Agreement or the application of any provision to any party or circumstance is prohibited by or invalid under applicable law, that provision will be ineffective to the extent of the prohibition or invalidity without invalidating the remainder of the provisions of this Agreement or the application of the provision to other parties and circumstances.

18. FORCE MAJEURE and SERVICE SUSPENSION

A. Except as provided below, neither party shall be in default for its failure to perform or delay in performance caused by events beyond its reasonable control including, but not limited to, adverse weather conditions, riots, imposition of laws or governmental orders, fires, pandemic and governmental orders related thereto, acts of God, and inability to obtain equipment, and the affected party shall be excused from performance during the occurrence of such event.

B. Any excuse or suspension of performance by a party pursuant to force majeure shall be only to the extent, and for a period of no longer duration than required by the nature of the event. The party claiming excuse from obligation shall use its best efforts in an expeditious manner to remedy its inability to perform and mitigate damages that may occur as a result of the event.

C. The party claiming excuse shall deliver to the other party a written notice of intent to claim excuse from performance of its obligations under this Agreement, whether partial or complete, by reason of an event of force majeure. Notice required by this Section shall be given promptly in light of the circumstances, but in any event no later than five (5) days after the occurrence of the event of force majeure. Such notice shall describe in detail the event force majeure claimed, the services impacted by the claimed event of force majeure, the expected length of time that the party expects to be prevented from performing, the steps which the party intends to take to restore its ability to perform, and such other information as the other party reasonably requests.

D. The partial or complete interruption or discontinuance of Contractor's services caused by an event of force majeure shall not constitute an event of default under this Agreement. Notwithstanding the foregoing, in the event of non-performance excused by force majeure, the City will have the right to perform and complete, by agreement or otherwise, the services herein or such part thereof as it may deem necessary and to contract with others to procure labor, equipment, and materials and incur all other expenses necessary for the completion of the services.

E. If the force majeure circumstances persist for more than thirty (30) days, the other party may terminate this Agreement without further penalty or liability.

19. EXTENT OF AGREEMENT

This Agreement, together with all Exhibits constitutes the entire understanding between the City and Contractor with respect to the subject matter of the Agreement and it supersedes, unless otherwise incorporated by reference herein, all prior representations, negotiations, agreements, or understandings, whether written or oral. Neither party has relied on any prior representations in entering into this Agreement. No terms or conditions of either party's invoice, purchase order, or other administrative document shall modify the terms and conditions of this Agreement, regardless of the other party's failure to object to such terms or conditions. This Agreement shall be binding on and shall inure to the benefit of the parties to this Agreement and their permitted successors and permitted assigns and nothing in this Agreement, express or implied, is intended to or shall confer on any other person or entity any legal or equitable right, benefit, or remedy of any nature whatsoever under or by reason of this Agreement. This Agreement may only be altered, amended, or modified by written amendment signed by Contractor and the City. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement.

20. ELECTRONIC TRANSACTION

The parties agree that signatures on this Agreement may be delivered electronically or by facsimile in lieu of a physical signature and agree to treat electronic or facsimile signatures as binding.

EXHIBIT A SCOPE OF SERVICES

A. Definitions

- a. **Business Day:** Any day, Monday through Friday, that is not designated a holiday, and any Saturday on which collection occurs because of the holiday schedule adjustment.
- b. **Civic Unit:** Any establishment defined under the Section 501(c) of Internal Revenue Service Tax Code that is eligible as a Curb Cart Recycle Customer under the terms of this Contract.
- c. **Commercial Customer:** Any commercial establishment defined under Chapter 26 of the City Code that is eligible as a Curb Cart Recycle Customer under the terms of this Contract.
- d. **Curb Cart Recycling Collection Service:** The collection of Recyclable Materials from Curb Cart Recycle Customers and the delivery of those Recyclable Materials to the Materials Recycling Facility.
- e. **Designated Facility:** That Material Recovery Facility site or other sites selected by the City to receive the materials that the Contractor must collect.
- f. **Downtown Development Authority District (DDA):** The Downtown Development Authority as described in Title I, Chapter 7 of the Ann Arbor Code of Ordinances.
- g. **Material Recovery Facility (MRF):** City's MRF located at 4150 Platt Road (south of Ellsworth Road), Ann Arbor, Michigan, or such other facility that is approved in advance by the City that is designed, operated, and legally permitted for the purpose of receiving, sorting, processing, storing, or preparing Recyclable Materials for sale.
- h. **Missed Collection:** Contractor failure to collect Recyclable Materials properly set out for collection by the Customer in accordance with the City's Solid Waste Regulations.
- i. **Mixed-Use Dwelling:** A building or structure which contains both Business(es) and Dwelling Unit(s).
- j. **Non-recyclable Materials:** Any material set out by the Customer that is not on the list of Recyclable Materials as described in the City's Solid Waste Regulations.
- k. **Recyclable Materials:** The list of Recyclable Materials as described in the City's Solid Waste Regulations.
- l. **Scheduled Lift or Tip:** Scheduled Lift or Tip means a single instance of the Contractor emptying a Curb Cart Recycle Customer's Recycle Curb Cart.
- m. **Service District:** means the city limits of Ann Arbor.

- n. **Recyclable Material:** Each load of material as weighed at the MRF scale (or other agreed upon scale in the case of unavailability or inaccuracy of the MRF scale) and delivered to the City of Ann Arbor's MRF tip floor or other agreed upon site that is collected on behalf of the City under the terms of this Contract.

- o. **Unserviceable:** A curb cart with Recyclable Materials that cannot be collected due to poor site conditions, including overfull, overloaded, blocked, or damaged containers as well as containers covered by snow and/or ice and containers with unacceptable material/items inside, which may include refuse, garbage, compost, industrial waste, construction waste, and debris.

B. Basic Performance Specifications

- a. **Grant of Exclusive Contract:** Except as otherwise provided in this Contract, Contractor is hereby granted an exclusive contract to provide Curb Cart Recycling Collection Service at all Curb Cart Recycle Customers within the Service District as listed in *Attachment I to Exhibit A*.

- b. Service Standards: Contractor shall perform all services under this Contract in a thorough and professional manner. All Collection Services described in this Contract shall be performed regardless of weather conditions or difficulty of collection. Adverse weather or other extraordinary circumstances in which case the parties shall follow the Force Majeure procedures set forth in paragraph 18 of this Agreement. Contractor shall perform all additional services described in this Contract professionally, promptly and courteously.
- c. General Conditions: The Contractor shall make its own determination as to conditions and shall assume all risk and responsibility and, unless the Contractor determines that conditions create a risk to employee safety, shall complete the work in and under whatever conditions it may encounter or create without extra cost to the City. All applicable State laws, municipal ordinances, and rules and regulations of all authorities having jurisdiction over the work to be performed shall apply to the contract throughout, and the same as though herein written out in full. The specifications for collection in no way limit the innovativeness of Contractor in its use of vehicles and personnel supplying Curb Cart Recycling Collection Service. However, any changes in the manner of service must be approved by the Contract Administrator.
- d. Labor and Equipment: Contractor shall provide and maintain all labor, equipment, tools, facilities, and personnel supervision required for the performance of Contractor's obligations under this Contract. Contractor shall at all times have sufficient backup labor to fulfill Contractor's obligations under this Contract. No compensation for Contractor's services or for Contractor's supply of labor, equipment, tools, facilities or supervision shall be provided or paid to Contractor by City or by any Customer except as expressly provided by this Contract.
- e. Holiday Service: City observes New Years Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day as legal holidays. Contractor shall not be required to provide services under this Contract or maintain office hours on these designated holidays. In any week in which one of these holidays falls on a business day, Collection Services for the holiday and each business day thereafter will be delayed one business day for the remainder of the week with normally scheduled Friday Collection Services being performed on Saturday.
- f. Accessibility of Streets: In those instances where a public or private street within the Service District is temporarily closed to vehicular traffic but is accessible to pedestrian traffic, Contractor shall utilize pedestrian access where practicable to manually provide Curb Cart Recycling Collection Service with no disruption of service to the Curb Cart Recycle Customers. In instances where it is not practicable to service Curb Carts manually using pedestrian access during a street closure, the City will facilitate arrangements to ensure recycle cart collection can occur during the street closure, which may include requesting early collection from the Contractor, requesting the street project team move carts to a serviceable designated area for pick up, or other options which allow for the provision of service.
- g. Commingling of Materials Prohibited.
 - i. Contractor shall not at any time prior to weighing the collected materials, commingle Recyclable Materials collected during the provision of Curb Cart Recycling Collection Service with Recyclable Materials collected during the provision of any other Recycling Service, without the express prior written authorization of the Contract Administrator.
 - ii. Contractor shall not at any time prior to weighing the collected materials, commingle Recyclable Materials collected pursuant to this Contract with any other materials, whether collected by Contractor or any other person, without the express prior written authorization of the Contract Administrator.

- h. Materials to be Collected: Contractor is responsible for collection of Recyclable Material placed in the recycling curb carts. Materials outside recycling carts will not be picked up.
- i. Spillage and Litter.
 - i. Contractor shall not litter premises in the process of providing Curb Cart Recycling Collection Service or while its vehicles are on the road. Contractor shall transport all Recyclable Materials in such a manner as to prevent the spilling or blowing of such waste from Contractor's vehicle. Contractor shall exercise all reasonable care and diligence in providing Curb Cart Recycling Collection Service so as to prevent spilling or dropping of Recyclable Materials during collection activity and shall immediately, at the time of occurrence, clean up such spilled or dropped Recyclable Materials.
 - ii. Contractor shall immediately cover with petroleum-absorbent material all equipment oil, hydraulic fluids, spilled paint, or any other liquid or debris resulting from Contractor's operations or equipment repair and shall remove the debris and the petroleum-absorbent material from the street surface before the end of the calendar day immediately following the day of the spill. When necessary, Contractor shall apply a suitable cleaning agent to the street surface to provide adequate cleaning.
 - iii. Contractor shall clean up any spillage or litter caused by Contractor within four (4) hours after notice from City. Such notice may be by telephone or email.
 - iv. To facilitate cleanup, Contractor's vehicles shall at all times carry sufficient quantities of petroleum-absorbent materials, brooms and shovels, and other appropriate cleanup materials or equipment.
- j. Curb Cart Recycling Collection Service. Contractor shall perform Curb Cart Recycling Collection Service in accordance with the following terms and conditions contained herein.
 - i. Conditions of Service: Contractor shall provide Curb Cart Recycling Collection Service to all Curb Cart Recycle Customers as listed in *Attachment I to Exhibit A: Curb Cart Recycle Customers* ("Customer(s)") whose Recyclable Materials are properly containerized in a Curb Cart Recycling Cart and have been properly set-out for collection in accordance with the City's Solid Waste Regulations.,
 - ii. Contractor shall not be responsible for collection where containers are blocked by snow, construction, or obstacles.
 - iii. Should the Customer determine that it generates on a regular basis more Recyclable Materials than will fit in the Recycling Cart, the Customer may request a second Recycling Curb Cart or an additional Scheduled Lift. Contractor and City, in their discretion, shall coordinate either delivery of a second Recycling Curb Cart or an additional Scheduled Lift. Materials outside the cart will not be picked up.
 - iv. Locations Receiving Service: Curb Cart Recycle Customers shall be designated by the City and shall include commercial locations, multi-family locations of eleven (11) or greater units, and civic units (for example, municipal parks, schools, non-profit agencies) where Curb Cart Recycling Collection Service is appropriate. Contractor shall determine actual Curb Cart locations and frequency of Scheduled Lifts as needed to maximize recovery and contractor performance. Contract Administrator has the option of canceling service to a Curb Cart Recycle Customer or adjusting the number of Scheduled Lifts if determined to not be appropriate or needed.
 - v. Frequency of Service: Contractor shall provide Curb Cart Recycling Collection Service to each Curb Cart Recycle Customer at least once every week on a scheduled route basis.
 - vi. Hours of Collection: For Curb Cart Recycle Customers outside of the DDA,

Contractor shall provide Curb Cart Recycling Collection Service commencing no earlier than 7:00 a.m. and terminating no later than 7:00 p.m., Monday through Friday, with no service on Saturday or Sunday except for Saturdays following City Holidays where collection is shifted by one day to account for the holiday. For Curb Cart Recycle Customers within the DDA, Contractor shall provide Curb Cart Recycling Collection Service commencing no earlier than 6:00am and terminating no later than 7:00pm, Monday through Friday, with no service on Saturday or Sunday except for Saturdays following City Holidays where collection is shifted by one day to account for the holiday. Exceptions to collection hours shall be made only upon the mutual contract of the City and Contractor, or when the Contractor reasonably determines that an exception is necessary in order to complete collection on an existing collection route due to unusual circumstances.

- vii. **Manner of Collection:** Contractor shall provide all Curb Cart Recycling Collection Service with as little disturbance as possible. Contractor shall leave any Recycling Cart in an upright position at the same point from which its contents were collected, without obstructing alleys, roadways, driveways, sidewalks or mailboxes. Contractor's employees providing Curb Cart Recycling Collection Service shall follow the regular walk for pedestrians while on private property and shall not trespass nor cross property to the adjoining premises unless the occupant or owner of both properties has given permission. Care shall be taken to prevent damage to property, including flowers, shrubs, and other plantings.
Quality Control Responsibilities: The Contractor shall service all Curb Cart Recycling Carts on a weekly basis, that meet the requirements of the City's Solid Waste Regulations, even if the Carts are only partially filled.
- viii. If the materials in a Cart do not meet the standards set forth in the City's Solid Waste Regulations, the Contractor shall tag the Customer's curb cart and notify the City. The Contractor shall develop a quality control sheet, to be approved by the City, that shall be left at the Customer's curb tagged to the Cart if over 12 percent Non-recyclable Materials are contained in the Cart. Contractor shall tag carts that are Unserviceable, do not meet the requirements of the City's Solid Waste Ordinance and its related Solid Waste Regulations (for example, unapproved materials, materials outside the carts, overflowing materials, etc.).
- ix. **Recyclable Material Overflow:** In the case of repeated set-outs of excess Recyclable Materials (overflow outside of container), Contractor shall notify the City of a desire to either increase the frequency of collection with additional Schedule Lifts or to add additional Curb Carts to Customer's location to eliminate the accumulation of excess Recyclable Materials. Contractor shall utilize email to provide the Contract Administrator with the details of the set-outs of excess Recyclable Materials, and request for increased service. Contractor shall not provide any additional Schedule Lifts without Contract Administrator approval. The Contract Administrator shall respond to Contractor's report and make a final written determination. Within five (5) business days of receipt of the Contract Administrator's written determination, Contractor shall provide additional Scheduled Lifts to the extent required by such written determination.
- x. **Spillage:** Contractor shall not be responsible for cleaning up sanitary conditions around Recycling Carts caused by the carelessness of the Customer; however, Contractor shall clean up any Recyclable Materials spilled from a Recycling Cart by Contractor or its employees. During transport,

all Recyclable Materials shall be contained, covered or enclosed so that leaking, spilling and blowing of the materials is prevented. Contractor shall be responsible for the immediate cleanup of any spillage caused by Contractor or its employees.

- xi. Inspections: City shall have the right to inspect the collection vehicles and their contents at any time while operating inside the City.
 - xii. Reporting of Problems and Non-Collections: Contractor shall use the City's work order management system, Cityworks, on a daily basis to report all situations that prevent or hinder collection; all instances of non-collection and the reason for the non-collection; and all instances of Curb Cart Recycling Carts in need of replacement, repair or exchange. Except as otherwise provided in this Contract, to the extent possible, Contractor shall make such reports by the end of the business day in which the event occurred; where it is not possible to make such reports by the end of the business day, Contractor shall report such events no later than the end of the next business day.
- k. Collection Trucks.
- i. Contractor shall provide all vehicles, materials, labor, water, tools, equipment, light, power, fuel, transportation, maintenance and other facilities necessary to perform Curb Cart Recycling Collection Services for the City's curb carts. The Contractor's collection vehicle fleet shall be able to service all curb carts including those on dead end streets, narrow streets, cul-de-sacs and dirt roads.
 - ii. Without limiting any other requirements or obligations of the Contractor, the Contractor shall meet or exceed the following standards with respect to collection vehicles used to perform Curb Cart Recycling Collection Services in the City:
 - 1. Throughout the contract term, all vehicles will have a high standard of aesthetics as to positively represent both the Contractor and the City;
 - 2. Contractor shall provide the City with an annual Fleet schedule with make, model and assigned identify number;
 - 3. The Contractor shall maintain all collection vehicles in a clean and sanitary manner; and
 - 4. All collection vehicles shall have appropriate safety markings, including operable highway lighting, flashing and warning lights, clearance lights and warning flags, all in accordance with applicable law(s). All collection vehicles and all parts and systems of all collection vehicles shall operate properly and be maintained in a condition compliant with all applicable laws, good industry standards, and be in a condition satisfactory to the City. Any vehicles not meeting these standards shall not be used within the City until repairs are made. All collection vehicles will be equipped with variable tone or proximity-activated reverse movement back-up alarms.
- l. Collection Containers.
- i. Container Purchase and Ownership: All collection containers and replacement parts for these containers will be purchased by the City and will remain the property of the City.
 - ii. Contractor shall at the end of each work day, submit through the work order management system (Cityworks) or equivalent, service requests for carts that are in need of repair, recycling, or disposal. The City will repair, deliver and dispose of carts.
 - iii. Contractor Caused Damage to Containers: The Contractor shall be responsible for loss or damage of any approved container caused by their agents or employees in the course of performance of their work and/or due to lifting mechanism or packing blade and shall fix or replace damaged carts at no cost to the owner or

occupant or the City. Contractor will not be responsible for replacement of carts damaged due to increased brittleness of older carts. Lifting mechanism may not be set to cycle in less than 9 seconds and must be fully compatible to dumping the approved City containers.

C. Service Changes.

- a. Curb Cart Recycle Customer Changes. The City and Contractor acknowledge that during the term of this Contract it may be necessary or desirable to add or delete Curb Cart Recycle Customers or Scheduled Lifts for Curb Cart Recycle Customers for which Contractor will provide Curb Cart Collection Services. Any resulting change to Contractor compensation as a result of additions or deletions will follow the procedure outlined in Exhibit B: Compensation.
 - i. Additions: Contractor shall provide initial or additional Curb Cart Recycling Collection Service described in this Contract to new Recycle Curb Cart Customer(s) within seven (7) days of receipt of notice from City that City has delivered a Curb Cart to customer(s) and to begin such Collection Services. Curb Cart Recycle Customers may also be added at the request of Contractor with approval of the Contract Administrator or at the request of the Curb Cart Recycle Customers and approval by the Contract Administrator. The Contract Administrator shall determine the type of Collection Services to be provided to any Curb Cart Recycle Customers that are added to Contractor's Curb Cart Service District. No Customers shall be added without approval of Contract Administrator.
 - ii. Deletions: Contractor shall immediately cease providing Curb Cart Recycling Service or reduce Scheduled Lifts to any Recycle Curb Cart Customer upon receipt of notice from City through email or the Customer Service System to stop such service. Curb Cart Recycle Customers may also be deleted because of a determination by the Contract Administrator that the premises do not qualify for the Collection Services to be performed by Contractor pursuant to this Contract.
 - iii. Annexation Addition or Intergovernmental Service Authorization: If during the term of this Contract, additional territory within or adjacent to the City is acquired by City through purchase, annexation, eminent domain or other procedures or a governing body with jurisdiction for territory adjacent to the Service District at that time enters into an intergovernmental contract with the City for Designated Services covered by this Contract, the Contract Administrator may designate such additional territory as part of Contractor's Service District. If the additional territory is so designated, Contractor shall provide the appropriate Designated Services, as determined by the Contract Administrator, in such additional territory in accordance with the provisions and service rates set forth in this Contract. Such Designated Services shall begin within fifteen (15) business days of receipt of written notice from the Contract Administrator. The Contract Administrator shall determine the type of Designated Services to be provided to any Curb Cart Recycle Customers in the additional territory added per this section. The Contractor shall add the Curb Cart Recycle Customers addition requested by the City to their next monthly invoice to be submitted to the City for payment.
 1. If at the time of service authorization by the City, the additional territory contains more than five hundred (500) Scheduled Lifts for Curb Cart Recycle Customers for which Contractor will provide Designated Services, Contractor may phase in the distribution of Containers on a schedule approved by the Contract Administrator; provided that Contractor shall complete the distribution of all Containers within ninety (90) business days after Contractor receives notification to begin Designated Services in the additional territory.

2. If at the time of service authorization by the City, the closest part of the additional territory is located more than 15 miles from the City of Ann Arbor MRF then Contractor may decline to provide the proposed Designated Services at the price provided for under the terms of this agreement at which time the City and the Contractor may negotiate alternate pricing mutually acceptable to both parties.
- iv. Curb Cart Route Maps. The Contractor shall supply the City with route maps of the Curb Cart Recycling Collection Area showing the day of the week Recyclables shall be collected from each sector. These maps shall be generated electronically and shall also include route boundaries, and route numbers. The Contractor shall also provide the City a listing, in Microsoft Excel format, of Customers where Curb Cart Recycling Collection Service is provided. The listing shall include the Curb Cart Recycle Customer address, number of curb carts, frequency of collection, and collection day(s). This listing shall be supplied on a quarterly basis or more frequently but not more than monthly if requested by the City. The City may withhold the Contractor's monthly payment if the list is not supplied within 60 days of the City's request. Attachment I of this agreement serves as the initial list of Curb Cart Recycle Customers serviced under this agreement.
 - v. Updated Route Maps: The Contractor shall revise the Curb Cart Recycling Service route maps, to show the addition or deletion of curb carts and Scheduled Lifts for Service Units as provided above and shall provide such revised maps to the Contract Administrator within seven (7) business days.
 - vi. Extraordinary Requests. Any requests by the Contract Administrator for an additional lift that is outside the normal scheduled route and that the city does not wish to be added to a regular scheduled route, will be invoiced separately in accordance with the procedure outline in Exhibit B.
- D. Customer Service and Reporting Requirements
- a. Contractor shall provide each of their drivers with the necessary equipment to take and upload pictures and provide mobile reports immediately following each missed pickup (unserviceable), and use the City's Cityworks system, or an alternative Contractor-provided system that is exportable to the City's database (Cityworks) and acceptable to the City, as the main point of contact for communication with the customer and the City. The driver shall also tag each unserviceable missed pickup and identify the reason for the missed pickup.
 - b. The Contractor shall maintain a representative who is available during normal business hours by telephone in the event of an emergency. The Contractor shall have a representative, or an answering service to contact the representative.
 - c. The Contractor shall respond to, log, track and report all customer complaints, inquiries and service requests, via Cityworks or other approved system, including: date and time of complaint/inquiry/service request; customer information (name, address, telephone number and e-mail) if the customer is willing to give this information; method of transmittal; nature of and details regarding the complaint/inquiry/service request; date, time, and manner of resolution of the complaint or service request; additional follow-up needed; date, time and details regarding follow-up conducted; and any service changes resulting from the resolution of the complaint/inquiry/service request. These items shall be logged daily. The Contractor will make a conscientious effort to resolve all complaints and service requests within one (1) business day of the original contact. If a longer response time is necessary for complaints or requests, the reason for the delay will be noted in the log, along with a description of the Contractor's efforts to resolve the complaint or request.
 - d. In the event that a Customer contacts the City directly with a complaint inquiry or service request, the City will transmit the inquiry/request via Cityworks to the Contractor who shall follow the directions for resolution as described in item D. above.

- e. The Contractor shall submit to the City within fifteen (15) days after the end of each month during the term of this Contract, the Monthly Report, which shall include a short summary (for example one-two pages) in the form of graphs, charts and other summary data of the following information:
- i. Total tonnage of all collected recyclables weighed at the MRF scale.
 - ii. Missed pickups by issue category (for example, weather, or lack of accessibility, etc.).
 - iii. Percent of recycling route completed on schedule.
 - iv. Number of carts tagged by issue category (for example, broken cart, yard waste in recycle).
 - v. Number of vehicular accidents or damage occurring to City/public property within the City limits.
 - vi. Number and type of spills that occur during the Recyclables Collection.
 - vii. Service Complaint Disputes: The Contractor will handle all service complaints in a prompt and efficient manner. In the case of a dispute between Contractor and a Customer, Contractor will refer the matter to the Contract Administrator for review. The Contract Administrator will review the matter and make a determination as to the resolution of the dispute.
 - viii. City Performance Standards for Missed Collections: For those complaints related to Missed Collections the Contractor will make a conscientious effort to resolve all complaints and service requests within one (1) business day of the original contact. If a longer response time is necessary for complaints or requests, the reason for the delay will be noted in the log. No matter the time of day - next business day before noon is the deadline Contractor will return to the Curb Cart Recycle Customer's address and collect the missed materials. At the end of each month the Contractor will provide the Contract Administrator a report including the response to each complaint which was received from a Customer within that month. In the case of repeated complaints related to the same location, Contractor shall coordinate with Contract Administrator to implement corrective actions. Curb Cart Recycling Carts that do not meet the requirements of the City's Solid Waste Regulations shall be considered Unserviceable.
 - ix. City Performance Standards for Repeated Missed Collections: Contractor acknowledges and agrees that it is in the best interest of City that all Recyclable Materials be collected on the scheduled collection day. However, in the event a Customer requests missed collection service more than two (2) times in any consecutive two (2) month period City will work with Contractor to determine an appropriate resolution to that situation. In the event Contractor believes any complaint to be without merit (e.g. late set outs or improper recycling), Contractor shall utilize the Customer Service System to notify the Contract Administrator. The Contract Administrator will investigate all disputed complaints and render a written determination within ten (10) business days of receipt of Contractor's notification.
 - x. Reporting to City: The Contractor will have the capability to report, via internet or email, to the City on the status of service complaints and missed pickups upon request of the Contract Administrator.
 - xi. Emergency Contact: The Contractor will provide the Contract Administrator with an emergency phone number where Contractor's representative authorized to act on Contractor's behalf can be reached outside of the required office hours.

EXHIBIT B COMPENSATION AND LIQUIDATED DAMAGES

General

Contractor shall be paid according to the attached Fee Schedule, in accordance with the terms and conditions herein.

For this term of July 1, 2026, to June 30, 2028, the Contractor fee for the services under this Agreement shall be adjusted according to the following schedule:

July 1, 2026, to June 30, 2027: **\$116,690.09 per month.** with an annual adjustment on July 1, 2027 equal to the lesser of 6% or CPI-U Midwest. For the purposes of this Agreement, CPI is defined as the Midwest Region Consumer Price Index for Statistics (BLS), United States Department of Labor. The change in CPI will be calculated in June for the previous twelve-month period (ending May 31st) and will be effective as of July 1st, and will be in effect for billings from July 1, 2027, through June 30, 2028.

Consistent with Amendment 10, once a reduction of **three thousand (3,000)** weekly cart tips has been completed (due to either conversion of curb cart collection to dumpster collection or businesses/multi-family buildings closing permanently) as documented by City and submitted to the Contractor, the fixed monthly fee shall thereafter be reduced by \$10,000. This \$10,000 reduction to the fixed monthly fee shall be reflected in the next full month's invoice one month after the end of the month in which the 3,000 weekly cart tip reduction is recorded for cart tip reductions achieved on or before the 15th of the month. For cart tip reductions achieved on or after the 16th of the month, the cost reduction will occur in the month following one full month after the 3,000 weekly cart tip reduction is achieved. For the purpose of clarity the following two examples are provided: If the 3,000 weekly cart tips reduction is achieved between October 1st and October 15th, then the \$10,000 reduction will be reflected in the Invoice covering services provided from the time period of November 1st to November 30th. If the 3,000 weekly cart tips reduction is achieved between October 16th and October 31st, then the \$10,000 reduction will be reflected in the Invoice covering services provided from the time period of December 1st to December 31st.

The number of recycle cart tip deletions shall be tracked in a Microsoft Excel spreadsheet and updated every month. If any additions to Curb Cart Recycling Collection service (e.g. new customers, additional carts, additional cart tips) are authorized by the Contract Administrator, then compensation shall be increased only if the number of additions exceeds the number of recorded deletions since the effective date of Amendment 10 (March 1, 2023). If an adjustment to compensation is required, each additional weekly tip shall be \$4.90. Once there are 3,000 weekly cart tips deleted from Contractor's service schedule, the number of recorded deletions will "zero out" and start back again from a count of zero. As of April 20, 2026, there are approximately 249 weekly cart tips that have been deleted from Contractor's service schedule.

Extraordinary requests for lifts will not be counted as additional lifts but will be compensated at a rate of \$ 4.90 per tip.

Invoice Procedure

Contractor shall submit invoices to the City on or before the fifteenth (15th) day of each month and the City shall pay Contractor within thirty (30) days of receiving invoices which are approved by the Contract Administrator. Contractor shall keep complete records of work performed (e.g. tasks performed/hours allocated) so that the City may verify invoices submitted by the Contractor. Such records shall be made available to the City upon request and submitted in summary form with each invoice. Failure to perform all the work as specified in this contract, shall obligate the Contractor to pay the City, as liquidated damages and not as a penalty, an amount equal to those listed in the **Liquidated Damages section below**. If any liquidated damages are unpaid by the Contractor, the City shall be entitled to withhold and deduct these unpaid liquidated damages from the monies due the Contractor, unless Contractor disputes the application of liquidated damages in which case liquidated damages will not be paid by Contractor or withheld from monies due to the Contractor unless and until the Contract Administrator makes a final determination sustaining the damages. The liquidated damages are for the non-quantifiable aspects of any of the previously identified events and do not cover actual damages that can be shown or quantified nor are they intended to preclude recovery of actual damages in addition to the recovery of liquidated damages.

Liquidated Damages

- A. The City and Contractor agree, in addition to any other remedies available to the City, the City may withhold payment from the Contractor in the amounts specified below as liquidated damages for failure of the Contractor to fulfill its obligations, not otherwise excused by this Contract, as determined by the City, unless they are disputed by Contractor. These amounts are liquidated damages for losses suffered by the City, and not a penalty.

1:	Failure or neglect to address Service Complaint(s) for identified single incident according to the time and manner set forth in this Contract.	\$50.00.
2:	Failure to clean up spillage or litter caused by Contractor.	\$250.00 per incident.
3:	Failure to repair, within a reasonable time, damage to customer property caused by Contractor or its personnel.	\$100.00 per incident.
4:	Failure to maintain office hours as required by this Contract.	\$50.00/hour or portion thereof but no more than \$250 per business day.
5:	Failure to maintain or timely submit to City all documents and reports as required by this Contract.	\$100.00 per business day.
6:	Failure of more than one truck to comply with the hours of collection operation as required by this Contract.	\$500.00 per business day.
7:	Failure or neglect to service each route on the regular scheduled collection day.	\$500.00 for each route not serviced.

8:	Commingling of materials collected inside and outside the Service District.	\$1,000.00 per incident.
9:	Failure of Contractor to report damaged cart within the time required by this Contract.	\$100.00 per business day.
11	Failure of Contractor's field personnel to carry photographic identification or wear uniform shirts.	\$25.00 per incident per business day.
12	Failure to deliver any collected materials to the Designated Facility as required by this Contract.	\$1,000 per truck incident

- B. Procedure for Assessment and Review of Liquidated Damages: The Contract Administrator may assess liquidated damages pursuant to this Article on a monthly basis. At the end of each month during the term of this Contract, the Contract Administrator shall issue a written notice to Contractor ("Notice of Assessment") of the liquidated damages assessed and the basis for each assessment.
- a. The liquidated damages assessment shall become final unless, within ten (10) business days of the date of the Notice of Assessment, Contractor provides a written request for a meeting with the Contract Administrator to present evidence that the assessment should not be made.
 - b. The Contract Administrator shall schedule a meeting between Contractor and the City Administrator or the City Administrator's designee as soon as reasonably possible after timely receipt of Contractor's request.
 - c. The City Administrator or the City Administrator's designee shall review Contractor's evidence and render a decision sustaining or reversing the liquidated damages as soon as reasonably possible after the meeting. Written notice of the decision shall be provided to Contractor.
 - d. In the event Contractor does not submit a written request for a meeting within ten (10) business days of the date of the Notice of Assessment, the Contract Administrator's determination shall be final and City may deduct the liquidated damages from amounts otherwise due to Contractor.
