*Kathleen Nolan, 2645 Easy Street, expressed concern about increasing residential density by developers and the Comprehensive Plan.*

*Kathy Griswold, 3565 Foxhunt Drive, raised questions about managing growth and pedestrian safety given existing infrastructure challenges noting that fatal crashes are on track to reach a decade high.*

*Jim Pike, 912 Pomona Road, expressed interest in a two-page executive summary outlining proposed changes to the Comprehensive Plan and spoke in support of eliminating exclusionary zoning.*

*Kirk Westphal, 3505 Charter Place, asked for clarification on certain elements of the implementation matrix, including regulations on larger units and potential contradictions with existing zoning policies and opposes incremental development.*

*Brian Chambers, 2115 Ember Way, advocated for including community land trusts as an affordable housing strategy within the implementation matrix.*

*Greg Monroe, 1261 Bending Road, called for removing references to R-1 and R-2 zoning, suggests pausing the plan, and expressed concern about displacement.*

*Brad Pritts, 3030 Lexington, emphasized the need for grassroots engagement in planning efforts and supports pausing the plan to ensure community acceptance.*

*Mark Scerbo, 2017 Fair Street, noted that new housing development is expensive and that upzoning can increase land values while potentially reducing cost per person.*

*2845 South State Street “Arbor South” Site Plan for Planning Commission Approval*

*A proposed site plan to construct approximately 15 new buildings in downtown-style development around two existing buildings at 777 and 789 E Eisenhower Blvd. New buildings include a hotel, eight residential*

*buildings, restaurant buildings, and three parking structures. The development proposes 93,500 square feet of new commercial space, approximately 150 hotel rooms, approximately 840 apartments or condominiums units including 230 affordable units, and approximately 2,500 vehicle parking spaces. Construction is planned in five phases on the 23.5-acre site is zoned TC1 (Transit Corridor) District.*
