The easement on Bill Lindemann and Karen Weidmayer property on Pleasant Lake Road in Lodi Township closed just before the end of the year.

Ms. Trocchio announced that just before the holidays, the USDA Farm and Ranchland Protection Program announced their grant cycle for 2012. The deadline is March 9.
