property in the Old West Side Historic District, to restore the wrap-around front porch, remove the non-original siding, construct a two-story rear addition, and construct a second-story addition on the east elevation on the condition that the decking, skirting, and stairs of the porch are wood. As conditioned, the work is compatible in exterior design, arrangement, texture, material and relationship to the rest of the building and the surrounding area and meets The Secretary of the Interior's Standards for Rehabilitation and Guidelines for Rehabilitating Historic Buildings, in particular standards 2, 9 and 10 and the guidelines for building site, new additions, entrances and porches, and wood, as well as the Ann Arbor Historic District Design Guidelines for all additions; additions to historic residential structures; and wood siding, trim, and architectural details.

As conditioned, the work is compatible in exterior design, arrangement, texture, material and relationship to the rest of the building and the surrounding area and meets The Secretary of the Interior's Standards for Rehabilitation and Guidelines for Rehabilitating Historic Buildings, in particular standards 1, 9 and 10 and the guidelines for building site, windows and health and safety, as well as the Ann Arbor Historic District Design Guidelines for windows, safety codes, and mechanical equipment.
