

**RENEWAL NO. 3 TO THE  
PROFESSIONAL SERVICES AGREEMENT BETWEEN  
CARLISLE/WORTMAN ASSOCIATES, INC.  
AND THE CITY OF ANN ARBOR FOR  
ON-CALL THIRD PARTY BUILDING, RENTAL AND PLANNING SERVICES**

This is Renewal No. 3 ("Renewal") to the Professional Services Agreement between Carlisle/Wortman Associates, Inc. ("Contractor") and the City of Ann Arbor for On-Call Third Party Building, Rental and Planning Services, dated 09-19-2018 ("Agreement"). City and Contractor are referred to collectively herein as "the Parties."

Terms:

1. The Parties agree to renew the Agreement for a period of 1 year(s) commencing July 03, 2023 and effective through July 02, 2024 ("Renewal Period").
2. The total costs of services for the Renewal Period shall not exceed Three Hundred and Fifty Thousand and No/100 Dollars (\$350,000).
3. The Parties agree that signatures related to this Renewal may be delivered electronically in lieu of original signatures and agree to treat electronic signatures as original signatures that bind them. The Parties agree that this Renewal and signatures related to the Agreement may be executed and delivered by facsimile and upon such delivery, the facsimile signature will be deemed to have the same effect as if the original signature had been delivered to the other party.
4. All terms, conditions, and provisions of the Agreement, unless specifically amended above, are to apply to this Renewal and are made a part of this Renewal as though expressly rewritten, incorporated, and included herein.

This Renewal shall be binding on the Parties' heirs, successors, and assigns.
