The petition must contain signatures of 60% or more of the households (i.e. street addresses) in the requested area. Where there are no other conflicting parking regulations, this program will restrict the parking of vehicles beyond a consecutive two (2) hour period, Monday through Friday, 8am-6pm, permit exempt.

Once a block has been designated, residents will be notified of the date when signs, if any, are to be posted and where they may obtain parking permits. Future streets within an Association boundary may be added by petition through the Association.

Good afternoon councilmembers,

I'm not sure if the Old West Side neighborhood association has brought this to your attention but they have petitioned to amend the Old West Side Residential Parking Area.
