Hello,

I am not certain I am able to attend the upcoming meeting in person however I would like to voice a strong opinion AGAINST the pricing increase. Please note the following as feedback given by a resident at the upcoming meeting.

We have lived in 9 various cities domestically, one being in the Lincoln Park neighborhood in Chicago, IL as well as 1 major international city abroad in the 7th most expensive country in the world, and this parking value/cost here is the highest we have seen. We live at City Club, so we have limited options that are all regulated by this department and are all extremely high. We originally looked at the outdoor lots thinking that would be more economical than a garage spot. We were SHOCKED at the price of parking for a dirt/gravel lot full of puddles in inclimate weather. We ended up going with the garage after looking at the other options and comparing pricing.

The rental cost is already exceptionally high in AA, and to pay \$200.00/month more per month to have a vehicle is proving living in the city as unjustifiable and something we will reconsider at the end of our lease terms. Decisions such as we are making will affect the housing in downtown AA, and there is a ripple effect from there.

As a married couple, we actually have 2 vehicles, but there is no way we could swallow \$400/month in parking just to live in an already outragousley priced environment. We are fortunate to be able to leave one of our vehicles at work, otherwise we would not have lived where we live.

The pricing aside, to pay \$200.00 for a hang tag that semi frequently does not work is an additional annoyance. We have a rigorous work hours and are on a timely schedule. To have to call semi frequently to get in or out of the lot costing time for something that we pay a hefty premium for is outrageous to consider raising the price of that product to the customer!

In addition to having our car robbed with no resolve, I'd also like to mention the frequency of homeless people lurking in or around the garage. We know there are signs relinquishing the parking services from responsibility and it is park at our own risk, however I do think the security and safety of us and our vehicles in a lot that we pay a heavy premium for should be taken into heavy consideration when evaluating raising cost or not.

Looking at the proposed pay rate scale increases in 2024-2026, this makes parking prices go from outrageous to a reason and need to move and find alternatives. I know for us as downtown tenants, this will definitely require us to reevaluate.

Hello,

My name is Riley Lulich. I am unable to attend the public hearing regarding parking rates due to the fact that it has been scheduled in the middle of the work day, but I would like to share my thoughts on the parking rate increase.

I have an administrative job in downtown Ann Arbor. One of my responsibilities is to be onsite five days a week, eight and a half hours a day, to accept deliveries, answer phone calls, and handle any emergent situations as they occur. I love my job. I love Ann Arbor, too. I've loved it since I moved here over four years ago.

What I don't love is how much I have to pay to work in Ann Arbor. Currently, one month consisting of four five-day work weeks costs \$216. That is just over a fifth of my rent. It costs me over \$2,500 every year to work in Ann Arbor. I am required to pay just over 8% of my wages to continue to have a job.

Public transit is not an option for me. It would more than double my commute time. Additionally, due to a physical disability, there are times that I can't make the walk to, from, and between bus stops.

I don't share this with you because I expect that you will decide not to raise the cost of parking. Instead, I ask you to please consider offering some type of employee pass or deal to ease the financial burden this increase places on those who work in Ann Arbor.

Thank you for taking the time to read my email. I hope you will consider my suggestion for future implementation.
