Dear Environmental, Transportation and Planning Commissioners and Members of the Economic Development Corporation (EDC),

(Sarah Higgins, I would appreciate it if you would forward this email to the members of the Economic Development Corporation.)

As you likely know, at its January 18, 2022 meeting, Ann Arbor City Council referred a "Resolution to Begin Discussions with U-M for Workforce Housing" to the Energy, Environmental, Transportation and Planning Commissions as well as the Economic Development Corporation; for details see agenda item DC-2 on p. 12 of the minutes available here:

The Energy Commission, which I chair, had a first reading of the resolution at its February 8, 2022 meeting, including a number of friendly amendments which were moved and seconded for further consideration. Those amendments had been previously shared with CM Griswold, who authored the original resolution draft, and she appreciated the edits.

The Energy Commission intends to finalize the wording of the resolution and vote on its approval in a second reading at its next meeting on March 8, 2022. Should your commissions or the EDC take up the referral prior to that date, I thought you would be interested in the Energy Commission's latest draft of the resolution which is attached; it has been slightly modified since the Commission's February meeting based on input provided during that meeting, where that input is summarized at the end of the document after the annotations. Hopefully the Energy Commission's draft helps inform your discussions of the resolution.

Feel free to share developments on the resolution which emerge from your commissions or the EDC with me and I will pass them on to the entire Energy Commission before our March meeting.
