### Annual Liquor License Review Process

*City staff presented to the Committee the process for the annual liquor license review, noting that invoices for renewals had been sent to all licensees of on-premise liquor consumption. City departments, including Treasury, Building, Fire, Police and Attorney had also been asked to review the applicants for renewal and provide recommendations.*

*The only objections came from Treasury for the following outstanding debts to the City:*

*Ann Arbor Distilling Company - \$107.13*

*Cafe Zola - \$8469.67*

*Nagomi Sushi (Plymouth Road) - \$2134.23*

*Nagomi Sushi (Liberty St.) - \$681.13 (2019) and \$621.03 (2020)*

*Shalimar - \$1106.94 (2019) and \$5431.83 (2020)*

*Councilmember Grand moved, seconded by Councilmember Griswold, that the City Clerk's Office proceed with a follow-up notice to the above licensees requesting payment by February 4, 2022 to prevent further action regarding the renewal of the liquor license. On a voice vote, the motion carried.*
