Hello, Ward 3 and 4 council members and Transportation Commissioners,

The neighborhood is thrilled that Hazel Coffee has finally opened in Packard Row. It has been instantly popular, and has created a new traffic condition that needs urgent remediation: Customers are parking on both sides of Crestland right up to the corner with Packard. It is creating unsafe conditions both for drivers turning off and onto Packard, and for pedestrians crossing Crestland and Packard. As you know, that Packard crosswalk is one of the only ones along this stretch, and Crestland is a school route for children traveling to Pattengill Elementary.

This seems like a great opportunity for a small quick build to daylight those corners. There are already signs telling people not to park there but drivers are routinely ignoring them, especially during the morning rush, which coincides with school drop-off car and bus traffic. Some paint and posts would go a long way.

While I understand and respect the prioritization process the city has for larger projects, this is a case where the condition is new as a result of a new business, and it was understandably not on any lists. It seems like this is the kind of situation the quick build program would be ideal for.

At minimum I hope you will consider non quick build solutions to address illegal parking at the corner of Crestland and Packard.
